### IMPORTANT INSTRUCTIONS

1. No. Pension shall be liable to seizure, attachment or sequestration by process of any court in India at the instance of a creditor for any demand against the Pensioner (Section II, Act XXIII of 1871)

2. Payment under this order is to be made only to the Pensioner in person with the following exceptions

(a) To person specially exempted by Government

(b) To females unaccustomed to appear in Public and to persons unable to appear on account of illness or bodily infirmity  
(Payment in both cases (a) and (b) is made on production of Life Certificate signed by responsible officer or Government, or other well known and trust worth person.

(c) Any person sending a life Certificate signed by some persons exercising the powers of Magistrate under the Criminal procedure Code, or by any Register or Sub-register appointment under the Indian Registration Act, 1908 by any pensioned Officer who, before retirement exercised the powers of a Magistrate or by any Gazetted Officer or by a Munsiff or by a Police Officer not below the rank of sub-inspector in-charge of police station or by a Postmaster, a Departmental Sub-Postmaster or an Inspector or Post Offices or by a Class I Officer of the Reserve Bank of India or an Officer of the State Bank of India or by the Head of a Village panchayat.

(c) To any person resident in India who draws his pension through an agent who has executed a bond to refund over payment subject to the condition that the latter produces at least once a year a Life Certificate signed by a person mentioned in clause.
