

Dear Architect,

Please find enclosed herewith the Certificate of Registration bearing Registration No. CA/ 2008 / 41780 in your favour, consequent upon your registration as an architect under section 25(a)/25(b) of the Architects Act, 1972 with initial validity of registration upto 31.12.2019. If you have opted for one time payment of renewal fee, the validity of your certificate, for the time being, has been further extended for ten years over and above the initial validity i.e. upto 31.12.2019. (Please see Testimonial enclosed).

Please note that no additions / alterations are to be made on the Certificate of Registration by an architect to whom it has been issued as it is only the Council authorised to make entries or effect changes on it. The Certificate of Registration must also not be laminated so that endorsements can be made on it from time to time upon receipt of renewal fee.


No individual intimation will be sent for payment of renewal fee towards renewal of registration. The period of validity is indicated on the Certificate of Registration itself. For any particular year, renewal fee falls due for payment on 1st January of the year and shall be paid before 31st March of that year by demand draft drawn in favour of "Council of Architecture", payable at New Delhi, failing which the name will be removed from the Register of Architects w.e.f 1st April of that year. In case the name is removed as a defaulter due to non-payment of renewal fee by the prescribed date i.e. 31st March, the same can be got restored on payment of Restoration Fee of Rs. 1,000/- and renewal fee, if any, by demand draft.

Those architects who have been registered on the basis of provisional/passing certificate issued by the competent authority of the University, shall be required to submit an attested copy of the final B. Arch/Dip. Arch./G.D. Arch. degree or diploma certificate received upon convocation, to this office as early as possible. It may be noted that their further renewal beyond three years from the date of registration shall be subject to submission of an attested copy of the final degree/diploma certificate.

Any recognised architectural qualification, which is included in the list of recognised qualifications appended to the Architects Act, 1972, can be got entered in the Register of Architects as well as on the Certificate of Registration on payment of additional qualification fee of Rs. 100/- per qualification by demand draft provided the additional recognised architectural qualification is obtained subsequent to the date of registration.






