NOW THIS DEED OF PARTNERSHIP WITNESSES AS FOLLOWS:-


- 1. Commencement of Partnership: The parties here agreed that the partnership firm shall come into force on the 15th day of February, 2018.

- firm shall carry on its business from its principal place of business at Mahabir Colony,









SECOND PARTNER (PUNAM SINGH) ... 50%


- 9. <u>Duration of Partnership:</u> The partnership shall be one at will.
