FEES REVISION INTIMATION

All registered architects are hereby informed that revised fees, with the approval of the Central Government, have come into force w.e.f. 26-09-1998. The revised fees are as under :

- (1) Registration Fee : Rs 300/- ; (2) Renewal Fee : Rs 200/- per year with an option for one time payment of Rs. 2000/-; (3) Restoration Fee : Rs 300/-; (4) Additional Qualification Fee : Rs 100/- (per recognised qualification); and (5) Duplicate Registration Certificate Fee : Rs 200/-.

Those who have paid renewal fee @ Rs 100/- per calendar year in advance from 1999 onwards are required to remit the balance of Rs 100/- per year and the endorsement(s) already made on the Certificate of Registration shall be valid in spite of revision of fees.

All payments should be made by demand draft or cheque favouring "Council of Architecture", payable at New Delhi (payment by an outstation cheque should include a bank commission of Rs 15/- extra).

In case the name is removed as a defaulter due to non-payment of renewal fee by the prescribed date i.e. 31st March, the same can be got restored including restoration of registration on payment of Restoration Fee of Rs. 200/- by demand draft.

Any recognised architectural qualification, which is included in the list of recognised qualifications appended to the Architects Act, 1972, can be got entered in the Register of Architects as well as on the Certificate of Registration on payment of additional qualification fee of Rs. 100/- per qualification by demand draft **provided** the additional recognised architectural qualification is obtained subsequent to the date of registration.
