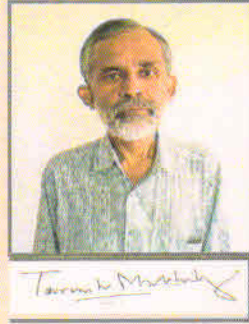

Council's various documents viz Act, Rules, Regulations & Guidelines, Fee Structure etc. with important Judgements, circulars and letters of Central/ State Governments are available at Council's website and may be accessed from there.

No additions/ alterations are to be made on the Certificate of Registration by an architect to whom it has been issued and the Council can make entries or effect changes on it. Please note that the original Certificate of Registration need not be sent/ brought to the Council office for any renewal/ endorsement.

In order to apply for renewal/further endorsement of your registration, you shall be required to login into your login account to view the option for online renewal and make online payment of renewal fee. After making payment, an online Digitally Signed Certificate (DSC) shall be generated by the system. This DSC shall be available for viewing/download at your login account and also emailed to you in a password protected pdf file. The certificate shall be a valid document for the purpose of indicating and confirming the validity of your registration as an architect.
