

- (5). Certificate of supervision for devolvement of land of area up to one hectare.


**CONDITIONS :-**

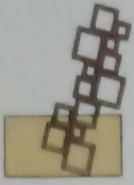
