In continuation of offer letter no. HO/HRD/CONT/2014/6515/C-2071 ddt. 22.08.2014, issued to you, we are pleased to inform with the approacal of the Competent Authority your engagement in HSCL (hereinafter referred to as "The Company") at our Ranchi Unit, will be on the following terms and conditions.

- 01 a) Your engagement will be purely on contract basis initially for a period of three years with effect from the date of your reporting for duty.
  - b) You will render your services as "Engineer Trainee (Civil)".
    c) You will report for duty to Head (Projects), HSCL Ranchi.
  - e) You was report for any to Head projects, HSCL, Rancht. d You will be paid remuneration of Rs 15,500°, (Rupees Fifteen Thousand Five Hundred) only consolidated per month. This will fall within the provision of Income Tax Act '1961, as applicable.
    - After completion of six months training period, you will be on probation for a period of six months which may be extended without notice at the discretion of the management.
