8. Accounts & Profit/Loss ratio: Proper books of account shall be maintained in the usual course of business and the same shall be closed once

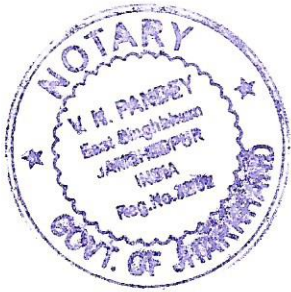
