5. That the parties hereto shall share the Profit/Loss of the Business in the following proportion:-

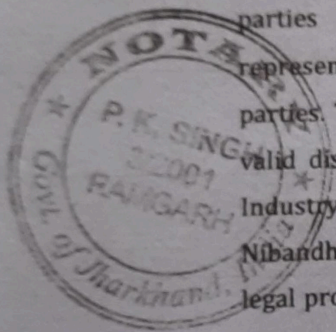

13. That the proper Books of Accounts shall be maintained recording therein all the transactions of the firm as and when they occur. Such books shall be kept at the office of the firm and shall not be removed from office except for firm's requirement or with consent of partners.

14. That no partner hereto shall without the written consent of the other partner :-

(a) Borrow any money for the purpose of the partnership business from any person whatsoever except from the other partner(s).

(b) Employ any of the money, goods or effects of the partnership business except in the ordinary course of the business and upon the account and for the benefit of the partnership business.

(c) Lend money or give credit on behalf of the partnership business or have any dealing with any person, Company or Firm whom the other partner(s) has/have previously in writing forbidden him to trust or to deal with.

Any loss incurred through any breach of this provision shall be made good to the partnership by the partner incurring the same.
