

Hereinafter referred to as the Party of the FIRST PART; (which expression shall mean and include his legal heirs, executors, administrators and assigns)

AND

(2) ANKITA BHARTI, (392542951355) D/O RATAN COMAR DAS resident of 474/410(J), WARD NO 10, SATYA NAGAN, GOODA, JHARKHAND - 814133,

Hereinafter referred to as the Ferry of the SECOND PART : (which expression shall mean and include his legal heirs, executors, administrators and assigns).

WHEREAS the above mentioned parties are desirous to carry on the business is main objects specified in para in partnerships in the name & style of GODDA CONSTRUCTION".

• AND WHEREAS the parties hereto have deemed it expedient to reduce into writing and are desirous of recording the terms and conditions governing their relations inter se.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO that they have become partners and joined in partnership upon the terms and conditions hereinafter expressed.

NOW, THEREFORE THIS DEED WITNESSETH AS FOLLOWS:

- (1) NAME: The name & style of the firm of Partnership shall be GODDA CONSTRUCTION. The Partners shall be entitled to carry on business under any other name and /or names as may be agreed upon mutually from time to time.
- (2) COMMENCEMENT: The Partnership firm shall be deemed to have commenced business on and from 21th of MAY 2022.
- (3) BUSINESS: The Main Objects of the firm shall be
 - (a) To carry on the business as builders, property developers, Engineering Contractors, Civil, mechanical and labour contractors building and erection engineers, consultants, dealers in importers, exporters and other items in connection therewith or incidental thereto,
 - (b) To carry on the business of contractors, our-contractors, quasicontractors and to undertake contracts and subcontracts, Labour Contacts.
 - (c) To carry on the business of support services including but not limited to placement services, enterprise content and data services, web services transports, Back office operations, manpower supplies etc.
- (4) PLACE. That the partnership business shall be carried on at BAI KUNTH NAGAR, MANGO, JAMSHEDPUR, PIN- 831012, DIST-EAST SINGHBHUM, JHARKHAND.

The Parties by mutual consent may carry on business at such other place or places, in such other name or names and of such other nature or natures, as they may deem fit and proper from time to time.

5) DURATION: The duration of the Partnership shall be "AT WILL" but in case any partner desires to retire from the partnership he shall be at

liberty to do so by giving one month's notice in writing to the other partners after settlement of all relevant accounts among the partners.

- (6) CAPITAL: The capital of the Partnership business as and when considered to be necessary and expedient for the purpose of carrying on business of partnership shall be contributed by the partners in the proportions as may be mutually agreed upon.
- (7) SHARE The net profit and /or loss of the partnership business after the al stamp of RS.3.15 payment of all expenses or other outgoings including the capital profits/or loss of any of the partnership firm shall be divided as under:-

- (8)BORROWINGS: The Partners of the firm may borrow from time to time after taking consent from the other partners from persons, firms, companies or banks, such money, as may be required for the purpose of the business of the firm.
- (9) BANK ACCOUNTS: That the bank account or accounts shall be maintained in the name of the firm and shall be operated jointly by the partners.
- (10) ACCOUNTING YEAR: The accounts of the partnership firm shall be taken are ually on 31st of March every year.
- (11) REMUNERATION TO PARTNERS: It is agreed by and between the parties hereto that the following partners (hereinafter referred to as working partners) who are devoting their time and attention in the conduct of the affairs of the firm as the circumstances and business needs may require and also handling day to day affairs of the business, shall be paid remuneration. The remuneration paid to the working partners shall be computed in the manner laid down in section 40 (b) (v), read with explanation 3 of the Income Tax Act, 1961 or any other applicable

provision as may be in force in the income tax assessment of the partnership firm for the relevant accounting Year. Such amount of remuneration shall be distributed between the working partners in the following proportion:

- (1) Mr.RISHIKESH NARAYAN SINGH 50 % of the total remuneration calculated as above.
- (2) Mrs. ANKITA BHARTI- 50 % of the total remuneration calculated as above.

The partners shall be entitled to increase or reduce the above remuneration and may agree to pay remuneration to other working partner or partners as the case may be. The partners may also agree to revise the mode of calculating the above said remuneration as may be agreed to by and between the partners from time to time.

(12) INTERST ON CAPITAL: That interest at the rate of 12% per annum or as may be prescribed under section 400)(iv) of the Incometax Act, 1961 or any other applicable provisions as may be in force in the incometax assessment of the partnership firm for the relevant accounting period or at a lower rate as may be agreed to by and between the parties from time to time shall be paid to the partners or credited to the partners on the amount standing to the credit of the account of the partners. Such interest shall be considered as an expenditure of the firm and shall be debited to the Profit & Loss Account of the firm before arriving at the divisible profit or loss.

(13)DRAWINGS: Each of the partners shall be entitled to draw from the partnership funds for his personal expenditure as may be mutually agreed upon between the partners, provided, however that such withdrawals shall not jeopardize the financial position of the firm.

DUTIES OF THE PARTNERS: Each one of the partners shall work dillgently and faithfully for the business of the partnership and shall extend

full co-operation to the other partners. Also each one of the partner shall sincerely render a true and correct account of each and every transaction handled by him and shall also give a reasonable explanation thereof, if and whenever so required by the other partners.

- (15) NOTICE OF RETIREMENT: Any partner may retire from the partnership business by giving a notice in writing of **one month** to this effect.
- (16) DISSOLUTION: That notwithstanding anything contained in the Indian Partnership Act it is hereby mutually agreed to by and between the parties that in case of death of any one or more partners, the firm shall no be dissolved but shall continue to be carried on by and between the surviving partners and legal heirs and/or representatives of the deceased partner, as a continuing concern, on the same terms and conditions as incorporated in this Deed or on such terms and conditions as may be agreed to by and between them from time to time. It is hereby further clarified that it shall be deemed as change in constitution and not succession.
- (17) ADMISSION OF NEW PARTNER: That if the partners deem proper and in their interest, they may admit any other person or persons as partners on the terms and conditions as may be mutually agreed amongst themselves
- (18)AS3. TRATION: That all disputes and questions in connection with the partnership or this deed arising between the partners or between any one of them or their legal representatives and whether during or after the partnership, shall be referred to the arbitrator in accordance with the provisions of the Arbitration and Conciliation Act, 1996 as amended from time to time whose decision shall be binding on the parties and their legal representatives
- (19) MODIFICATION: All other matters for which no provisions has been under in this Deed and also matters for which are to be eliminated and/or

modified shall be decided with the mutual consent of all the partners shall be reduced to writing and also be signed by all the partners and shall form in an appendage to this partnership deed.

- (20) STIPULATIONS: (a) No partner without the consent of the other partners give in writing, secure any surety or guarantee for any other person or do or knowingly suffer anything to be done whereby the partnership property may be endangered.
- (b)No partner shall without the written consent of the other partners dispose off by way of pledge or otherwise any of the assets of the partnership business.
- (c) All partners of the firm shall be individually and wholly responsible to pay their personal taxes and other dues. They are responsible for their personal liabilities.
- (d) All the partners of the firm shall have rights on the movable and immovable properties belonging to the firm in their profit sharing ratio.
- (e) Every partner shall indemnify the firm for any loss caused to it by his fraud or willful neglect in the conduct of the business of the firm.
- (f) All bonds, bills, notes, bills of exchange, or other securities given on behalf of the partnership (except cheques) shall be signed, endorsed, accepted or executed jointly by all the partners and any bond, bill, note, bill of exchange, etc. to which any partner may be a party contrary to this provision shall be deemed to have been on the personal account of such partner and he shall pay and discharge the same out of his own moneys and indemnify other partners and the firm against payment thereof and against all actions, proceedings, costs, charges, expenses, claims and demands in respect thereof.

(21)GENERAL: That in all respects other than those provided from herein this partnership shall be governed by Indian Partnership Act, 1932 together with its modifications for the time being in force.


