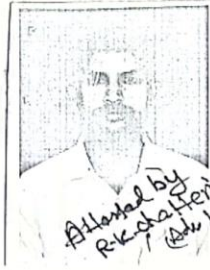

However, in keeping with the profitability of the business, gross remuneration to a particular partner shall not exceed Rs.10,000/- per month per person.

THAT ACCOUNTS will be settled and adjusted each year on the 31st day of March and on such adjustment will be final and binding on all the partners provided always that if any manifest error is pointed out by any PARTNER within 01 (one) month of the adjustment it will be corrected by the PARTNERS.



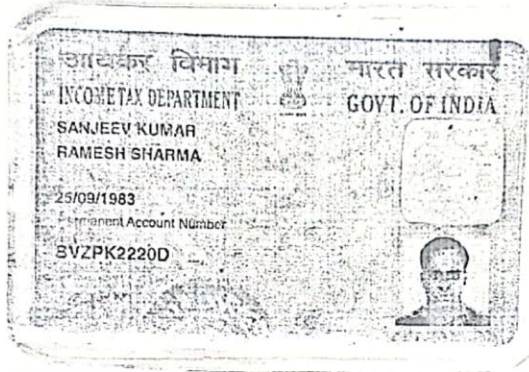

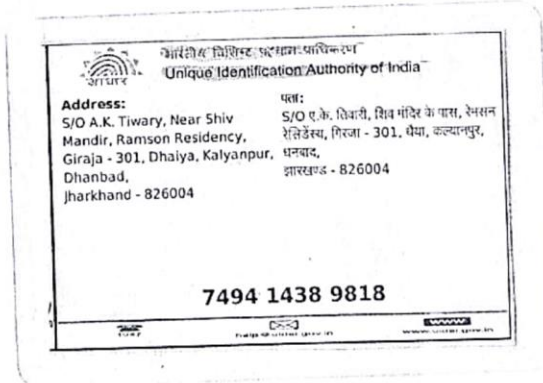
