AND

Ms. ASHA PANDEY D/O MR. RADHA RAMAN DUBEY, by faith Hindu and by occupation business, Resident of Flat No. -2 AB, RAMKRISHNA APARTMENT, SHUKLA COLONY, Hinoo, Ranchi, Jharkhand-834002, hereinafter referred to as party of the SECOND PART (which expression shall deem and include her heirs, executors, administrators, representatives, assigns), AND

Mr. HRIDAY NATH PANDEY S/O LATE RAM SWAROOP PANDEY, by faith Hindu and by occupation business, Resident of Flat No. -2 AB, RAMKRISHNA APARTMENT, SHUKLA COLONY, Hinoo, Ranchi, Jharkhand-834002, hereinafter referred to as party of the THIRD PART (which expression shall deem and include his heirs, executors, administrators, representatives, assigns),
AND

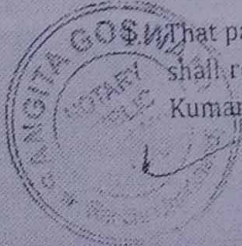

WHEREAS the above named partners have been carrying the partnership business under the name of M/s SARSWATI CONSULTANCY & CONSTRUCTION, having its office at FLAT NO-2 AB, RAMKRISHNA APARTMENT, HINOO, DISTRICT: RANCHI - 834002 (Jharkhand) on the terms of Partnership Deed dated 03rd June 2015.

And whereas the party of Second and Third Part (i.e. Ms. Asha Pandey and Mr. Hriday Nath Pandey) has expressed their desire to retire from the said partnership firm w.e.f. 16th November, 2021 and the party to the Fourth Part (i.e. Mr. RAJESH KUMAR SHRIVASTAVA) has expressed his desire to join the firm and parties of 1st and 4th have agreed to continue the business on the terms & conditions mentioned hereinafter.

NOW THIS INDENTURE IS WITNESSETH AND IT IS HEREBY COVENANTED AND FINALISED
BY AND BETWEEN THE PARTIES AS FOLLOWS:

That party of 2nd part (i.e. Ms. Asha Pandey) and 3rd part (i.e. Mr. Hriday Nath Pandey) shall retire from the firm w.e.f. 16-11-2021 and party of the 4th part (i.e. Mr. Rajesh Kumar Shrivastava) is admitted on the same day.



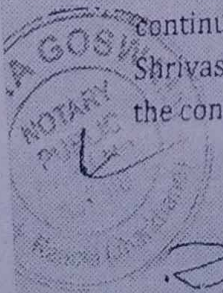

2. THAT an account has been taken of the State of Affairs of firm as on 16-11-2021 which has been mutually settled & now there is no dispute regarding accounts of the firm.
3. THAT balance amount standing to the credit of the retiring partner (i.e. Ms. Asha Pandey and Mr. Hriday Nath Pandey) is discharged by the continuing partner.
4. The Continuing Partners admit the New Partner as a Partner of the said Partnership in place of the Retiring Partner and on the basis of the same terms and conditions as are contained in the said Deed of Partnership Deed. Hereinbefore recited as if the New Partner was a party to the said Deed of Partnership in place or stead of the Retiring Partner except that the New Partner will not be entitled to the benefits by way of profits earned during the period upto the date of these presents.
5. That the continuing parties of 1st and 4th Parts (Mr. Rudradeo Kumar and Mr. Rajesh Kumar Shrivastava) have taken over the partnership business on the basis of Balance Sheet prepared as on 15-11-2021 and henceforth all the assets & Liabilities of partnership firm shall belong to the said continuing parties of 1st and 4th parts.
6. That the retiring party of 2nd and 3rd part (i.e. Ms. Asha Pandey and Mr. Hriday Nath Pandey) shall have no right upon the future Profits of the firm.
7. That the continuing parties of 1st and 4th Parts (Mr. Rudradeo Kumar and Mr. Rajesh Kumar Shrivastava) shall be entitled to carry on the business in the name of the firm but the retiring party of (2nd and 3rd part) shall not be entitled to carry on the business in the name of this firm.
8. That the continuing parties of 1st and 4th Part shall enjoy the exclusive rights towards Goodwill, Licences, Land, Building & other assets of the firm and will be at liberty to take in any person or persons as partner in the firm in future.
9. That the retiring partner of (2nd and 3rd part) shall be liable for all taxes & penalties and entitled to Refunds up to 15-11-2021 in their profit sharing ratio.
10. That continuing parties (1st and 4th part) shall be responsible to get complete all kinds of pending cases.
11. In case any dispute between the parties, the same shall be referred to Arbitration.
12. That the parties of (1st and 4th part) to this agreement shall sign, execute and do all such further documents, deeds acts & things as the other party may reasonable require for completely affectuating this Agreement. In case retiring party of 2nd and 3rd part (i.e. Ms. Asha Pandey and Mr. Hriday Nath Pandey) do any such act or thing by which the continuing part of 1st and 4th part (i.e. Mr. Rudradeo Kumar and Mr. Rajesh Kumar Shrivastava) suffer any loss, He (Mr. Rudradeo Kumar) will be liable to compensate the continuing parties of 4th part.

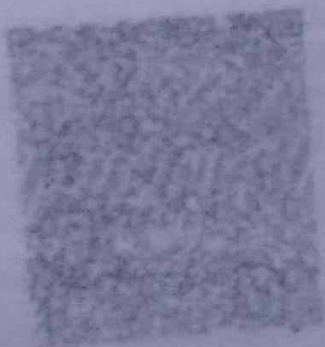
