Sri Ashok Kumar son of Late Ganga Prasad, resident of Pyari Devi Bhavan, Lower Karam toli, Morabadi, Ranchi (hereinafter called the Second Party) of the Second Part;

And

Sri Gopal Chandra Singh son of Late Hari Ram Singh, resident of "Anand Bhavan" Apartment, Mariatu Road, Near Dr. K. E. Sinha Residence, Ranchi (hereinafter called the Third Party) of Third Part;

The terms first Party, Second Party, and Third Party include their respective he irs, executors, administra tors, successors-in-interest, legal representatives and essigns

Whereas the Parties aforesaid have agreed among themselves to constitute a Partnership for carrying on business in Private and Government Contract and services or any other business under the name & style of "M/s KRI Gopel Charana linge 99 12/2022 29/12/22 29/12/22 DEVEL OPERS" .

And whereas it has now been deemed or expedient to draw up a formal deed of Fartnershin incomporating the terms and conditions as agreed upon;

NO W THIS DEED OF MARIN FRSHIP WITNESSETH AS UNDER :-

- 1. That the Partnership business shall be carried on under the name and tyle of "M/s KRITI DEVELOPERS".
- 2. That the Head Office of the Partnership firm shall be located at Ganga Ashram Complex (Ganga Residency), Kutchery Road, Ranchi-834001.

Frovided that the Parties may by common consent shift the Head Office of the firm to any other place as may be deemed expedient from time to time.

- 3. That the business of Partnership shall mainly constitute of Construction and Development of land at different locations/places.
- 4. That the Partnership shall be deemed to have commenced from. 29:12.2022
 - 5. That the capital necessary for running of the business of Partnership shall be provided by the Partners proportionately.

- 6. That the respective share of parties in Profit & Loss of the business shall be in the following proportion:-
- 1. Gyan Kirti Kumar Sinha _ 33.3%
- 2. Ashok Kumar 33.3%
- 3. Gopal Chandra Singh 33.3%
- That all the Partners will be active working Partners and they shall perform such duty from time to time as they mutually agree and in consideration thereof they shall be entitled to a minimum remuneration as prescribed u/s 40(b) of the Income Tax Act, 1961.
- 8. That interest will be charged at the rate of 12% per annum from time to time towards the capital invested by all the Partners.
- 9. That the accounting year of the firm shall end with the 31st day of March each year. At theend of each such accounting period or soon thereafter a Profit & Loss Account and a Balance Sheet for the previous year shall be drawn up and profit & Loss as the case may be distributeed among the Partners in proportion to their respective shares.
- 10. That the necessary books of accounts as are usually maintained in case of similar business shall be maintained and kept at the Head Office of the firm and all the Partners

shall have access over the same.
