- 2. That this partnership has commenced and shall be deemed to have commenced on and from today and the duration thereof shall be "AT WILL".
- 3. That any other branch or branches may be opened at any other place or places in Jharkhand State under such name as the parties here may agreed upon time to time.
- 4. That the business of the firm shall be construction of buildings and other construction works, Civil Construction, Sale and purchase of land and Flat, Development works etc. and doing such other business or businesses as can Conveniently and advantageously be carried on and also such other business or venture in addition to or in substitution of the said business as may done time to time be detainment by the mutual consent of the parties hereto.
 - 5. That the necessary capital as well as further funds required for the business of the firm shall be invested by both the partners equally.
 - 6. That the net profit of the firm business as per the accounts maintained by the partners after deduction of all expenses relating to activities of the firm including rent, salaries and other establishment expenses as well as interest and remuneration

payable to PARTNERS in accordance with this deed of partnership shall be divided and distributed amongst the parties hereto in the following proportion:

- I) Sanjay Kumar Lakhani-First Partner 50% of the Profit or Loss.
- II) Rakesh Goyal Second Partner 50% of the Profit or Loss.
- 7. That all partners will governed by the Income Tax Act as laid down in Sec-40 regarding the remuneration of the Partners.
- 8. That all accounts of this FIRM, its assets and liabilities and its profit and losses shall be taken on the 31st day of March of each year or any other convenient date suitable to the parties hereto.
- 9. That the business of the firm shall be managed and conducted by both the Partners.
- 10. That each of the parties hereto shall have authority to represent and act on behalf of the firm in the court, revenue office, income tax, sale tax office, or any other office or commercial taxes whether in original or appellate or reversionary stage and in any government, semi-government or private office, firm, company, bank association, institution, department and organization etc.

- 11. That all the corporate money and securities money shall be and when received be paid and deposited into the credit of the firm account and all the receipts on behalf of the firm and all payments out of the fund of the firm shall duly entered into the books of accounts of the firm.
- 12. That the bank accounts in the name of the firm shall be opened with such bank or banks from time to time. The Account so opened, shall be operated by joint signatures of the partners.
- 13. That the parties hereto may by mutual consent add to, alter, vary or modify any of the terms of the partnership to their mutual advantage and in the interest of the firm. Such consent will always be presumed by the conduct of the parties and other available circumstances.
- 14. That the firm can raise loan or loans from government, semi-government, bodies or other financial institution or from the general public to carry on the business of the firm with or without interest.

- 15. That necessary book of accounts as usually maintained in course of business shall be maintained and kept at the head office of the firm. Each party or their authorised representatives shall be entitled to inspect such books of accounts and take notes/extracts there from at their own cost.
- 16. That new PARTNER OR PARTNERS may be taken in the firms and conditions as to share of profit otherwise may be mutually decided by the parties hereto.
- 17. That each of the parties here to shall have right to retire from the firm after giving one month notice to the other parties hereto and on retirement from the firm the other party shall have right to carry on the business in the name of the firm but remaining partners shall be liable to pay to the retire partner the credit balance standing in such party's name along with such share of profit, interest and remuneration till the date of dissolution.
- 18. That on the complete dissolution of the partnership firm by the mutual consent on special unavoidable circumstances. The parties hereto shall cause a full and accurate inventory to be prepared of the affairs of the partners taking into account all the assets,

liabilities, existing or contingent as well as goodwill of the partnership. The losses including deficiencies of the capital shall be paid first out of the capital and lastly, if necessary by the parties individually in the proportions to which they were entitled to share profits.

- 19. That in case of death of any party hereto the heirs or legal representatives of the deceased party shall be admitted in his place as partner in the partnership on the same terms and conditions as deceased party was entitled to under the present or on any other terms as may be agreed upon by the surviving partners and the heirs or legal representatives of the deceased party singly unwillingness to become partner or partners of the surviving party shall be entitled to carry on the business of the firm but they shall be liable to pay to the heirs or legal representatives of the deceased party the credit balance standing in the name of the deceased party along with the profit, interest and remuneration till the date of death.

That in case of any dispute, doubt or difference arising in relation to the constitution, meaning or interpretation of the partnership deed or any terms thereof or in respect of the partnership account, profit or loss or rights, liabilities or obligation in this partnership firm. However the decision taken by the First Party will be final and will be binding upon the other two partners.
- 24. That subject to the terms aforesaid the affairs of the firm and the relation between the partners aforesaid shall be governed by the provision of the Indian Partnership Act 1932 (as amended from time to time).


