Preliminary

- 1. Unless the context otherwise requires, words or expressions contained in these regulations shall bear the same meaning as in Companies Act. 1956 or any statutory modifications thereof in force at the date at which these regulations become binding on the Company.
- 2. The provisions of the Companies Act, 1956 including Table 'A' shall apply to the Company, so far as the same are not altered, modified, repealed or added hereunder and as are applicable to a Private Limited Company.
- 3. The Company is a Private Limited Company within the meaning of Section 2 (35) and 3 (1) (iii) of the Companies Act, 1956 and accordingly
 - (a) The Number of members of the Company for the time being (not including person who are in the employment of the Company and persons who having been formerly in the employment of the Company were members of the Company while in the employment and have continued to be members after the employment ceased) is not to exceed fifty provided that where two or more persons hold one or more shares in the Company jointly they shall, for the purpose of this definition, be treated as a single number.

- Subject to the provisions of section 201 of the Companies Act, no director 79. or other officer of the company shall be liable for the act, receipts, neglected or defaults of any other Director or for joining in any receipt, or other act for the sake of conformity or for any loss or expenses happening to the Company through insufficiency/deficiency of any security or investment in or upon which any of the moneys, securities or effects shall be deposited or for any loss, damage or misfortune whatever which shall happen in the execution of the duties of his office or relating there to unless the same happen through his own negligence, default, mischief, or dishonesty.

Arbitration

Whenever any difference or disputes relating to the interpretation of the 80. articles arise between the Company on the one hand and any of the members, their executors, administrators or vis-à-vis assignees on the other hand or the directors or the managing director, the same shall be referred to arbitrator mutually agreed or arbitrators one to be nominated

by each disputant and their decision shall be binding on the parties concerned. In case arbitrators are unable to decide amongst themselves on the points referred to them, they shall refer to an umpire appointed as provided under Arbitration Act.

Winding up

81. If the Company shall be wound up, the surplus assets shall (subject to any right attached to any special class of shares forming part of the capital for the time being of the company) be applied first in repayment of capital paid up on the equity shares, and that the excess (if any) shall be distributed among the members holding equity shares in proportion to the number of equity shares held by them respectively at the commencement of winding up.
