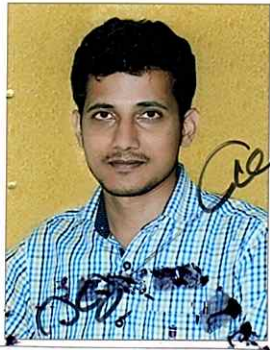

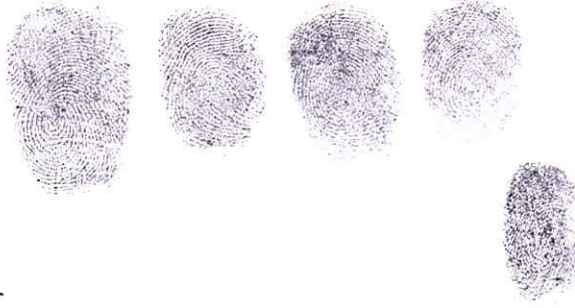


final and binding upon all the partners hereto, if the above endeavour fails, the provisions of the Indian Arbitration Act, shall apply.
