3.(a) The objects to be pursued by the company on its incorporation are

1. To carry on business in India or elsewhere the business to construct, develop, build, construct, run, repair, maintain, build, alter, acquire, convert, improve, operate and manage roads, building, public place and other structures, and to do design, erect, establish, equip, develop, dismantle, pull down, turn to account, furnish, level, decorate, fabricate, install, finish, repair, maintain, search, survey, examine, taste, inspect, locate, modify, own, operate, protect, promote, provide, participate, reconstruct, grout, dig, excavate, pour, renovate, remodel, rebuild, undertake, contribute, assist, and to act as civil engineers, architectural engineer, interior decorator, consultant, advisor, agent, broker, supervisor, administrator, contractor, subcontractor, turnkey contractors and manager of all type of constructions & developmental work in all its branches such as roads, ways, culverts, water tanks, reservoirs, warehouse, factories, buildings, structures, drainage, & sewage works, water distribution & filtration systems, piers, irrigation works, foundation works, rock drilling, aqueducts, stadiums, sanitary works, power supply works, power stations, hotels, hospitals, multistory, colonies, complexes, housing projects and other similar works for the purpose to acquire, handover, purchase, sell, own, cut to size, develop, distribute or otherwise to deal in all sorts of lands & buildings.

2. To purchase any land, plot(s) of land or immovable property or any right or interest therein either singly or jointly or in Partnership with any person(s) or Body corporate or partnership Firm and to develop and construct thereon residential, commercial complex or complex(es) either singly or jointly or in partnership as aforesaid, comprising offices for sale or self-use or for earning rental income thereon by letting out individual units comprised in such building(s).

3. To purchase any movable or immovable property including industrial, commercial, residential, or farm lands, plots, buildings, houses, apartments, flats or areas within or outside the limits of Municipal Corporation or other local bodies, anywhere within the Domain of India, to divide the same into suitable plots, and to rent or sell the plots for building/constructing residential houses, bungalows, business premises, and colonies and rent or sell the same and realize cost in lump sum or easy installments or by hire purchase system and otherwise.

3.(b) Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To purchase and or otherwise acquire and undertake the whole or any part of the business property, rights and liabilities of any person, firm or body corporate carrying on or proposing to carry on any business which this company is authorized to carry on, or possessed of property or rights suitable for any of the purposes of the company of which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company and to purchase, acquire, sell and deal in property, share, stocks, debenture stocks, of any such person, firm or body corporate and to conduct, make or to carry into effect any arrangements in regard to the winding up of the business of any such person, firm or body corporate.

2. To borrow or raise money in such manner and upon such terms as may seem expedient, and to secure the repayment thereof and of moneys owing or obligations incurred by the Company, and to create, issue and allot redeemable or irredeemable bonds, mortgages or other instruments, mortgage debentures (such bonds or debentures being made payable to bearer or otherwise and issuable or payable either at par, premium, discount, or as fully paid) and for any such purposes to charge all or any part of the property and profits of the Company both present and future including its uncalled capital.

3. To acquire, purchase movable, immovable properties, to amalgamate, barter, exchange, join, control, hold, manage, own, participate,

undertake or otherwise to take over the running business as a going concern of any partnership firm, proprietorship firm, person, association of persons, body of individuals, corporate bodies, companies or other organizations together with all its assets, liabilities, rights, goodwill, entitlements, licenses, registrations, privileges, trademarks, patents, designs, know how, secrets, obligations, assignments, bookings, contracts, commitments, goods, articles & things and to discharge the takeover consideration either in the form of cash, kind, release, transfer, extinguishments, relinquishment, surrender or by issue of fresh shares of the companies and to do all incidental acts and things necessary for attainment of the foregoing objects.

4. To carry on in India or elsewhere the business to generate, receive, produce, improve, buy, sell, resell, acquire, use, transmit, accumulate, employ, distribute, develop, handle, protect, supply and to act as agent, broker, representative, consultant, collaborator, or places as may be permitted by appropriate authorities by establishment of thermal power plants, hydraulic power plants, atomic power plants, wind power plants, solar power plants and other power plants based on any source of energy as may be developed or invented in future.
5. To buy, sell, alter, improve exchange, let out on hire import, export in all companies, and deal all products residual and by-product incidental to or obtained in any of the business carried on by the Company.
6. To purchase, take on lease or tenancy or in exchange, hire take, option over or otherwise acquire any estate or interests, whatsoever and to hold, develop work. Cultivate, deal with, and to account concessions, grants, decrees, licenses, privileges, claim, option leases, property, real or personal or rights or power of any kind which may appear to be necessary or convenient for any business of the company.
7. To pay or issue shares for preliminary and pre-incorporation expenses of the Company.
8. To sell, exchange, mortgage, let on lease, royalty or tribute, grant licenses, easement, option and such other rights over and in other such manner deal with or dispose of the whole or any part of the undertaking, property assets, rights and effects of the company for such consideration as may be thought fit and in particular for stock, share debentures whether fully or partly paid up or securities of any other such company having objects whole or in part similar to those of the company or as may be approved by the shareholders.

To pay for any rights or property acquired by the company and to remunerate any such person, firm or body corporate rendering services to the company either by cash payment or by allotment to him or them of shares or securities of the company as paid up in full or in part or otherwise.

10. To guarantee the performance of any contract or obligation and the payment of money or dividends on any stock, Shares or securities of any company, corporation, firm or person in any case in which such guarantee may be considered directly or indirectly to further the main objects of the Company.

11. To draw, make, accept, endorse, discount, negotiate, execute and issued bills of exchange, promissory notes, bills of lading, debentures and other negotiable or transferable instruments or securities.

12. To apply for, purchase or otherwise acquire and protect, prolong and renew in any part of the world, any patents, patent rights, brevets, trademarks, designs, licenses, protections, and concession conferring any Executive or non-executive or limited right to use information as to any invention, process or privileges which may seem capital of being used for the objects of the Company or the acquisition of which may seem calculated directly or indirectly, to benefit the Company and to use, exercise, develop or grant licenses or privileges in respect of or otherwise term to account, the property, rights and information so acquired.

13. To spend money in experimenting upon and testing and improving or seeking to improve any patents, right, inventions, discoveries, processes or information of the Company or which the Company may acquire or purpose to acquire.

14. To do all or any of the main objects either as principals, agents, trustees, contractors or otherwise and either along or in conjunction with others and either by or through agents, sub-contractors, trustees or otherwise.

5. To procure the registration or recognition of the Company in or under the laws of any place outside India.

To form, incorporate or promote any company or companies whether in India or elsewhere having amongst it or their objects the acquisition of all of the assets or controls, management or development of the Company or any other such objects which in the opinion of the Company could or might directly or indirectly assist the Company in the management of its business or the development of its properties or otherwise prove advantageous to the Company to pay all or any of the costs and expenses incurred in connection with any such promotion or incorporation and to remunerate any person or about the formation or promotion of the Company or the conduct of its business or in about the promotion of any other such company in which the Company may have any interest.

To enter into any arrangements and take all necessary or proper steps with Government or with other such authorities, supreme, national, local, municipal or otherwise of any place in which the Company may have interests and to carry on any negotiations operations for the purpose of directly or indirectly carrying out the object of the Company or effecting any modification in the constitution of the Company or for furthering the interest of the members and to oppose any such steps taken by any other such Company, firm or person which may be considered likely, directly or indirectly, to prejudice the interest of the Company or its members, and to assist in the promotion whether directly or indirectly, of any legislation which may seem advantageous to the Company and to obtain any such Government authority and company any charters, contracts, decrees, rights, grants, loans, privileges, or concession which the company may think it desirable to obtain and carry out, exercise and comply with any such arrangements, charters, decrees, rights, privileges or concessions.

18. To design develop, promote, launch or establish websites or portals to provide own information to general public for the promotion of business and commerce under one or more domain names.
