1. This reconstituted Partnership Deed shall commence and deemed to have commenced partnership with effect from 22<sup>nd</sup> day of December , 2018 and the earlier partnership deed executed on 3<sup>rd</sup> day of September 2002 shall stand revoked and cancelled.

#### NAME & PLACE OF BUSINESS

2. (i) That the name and style of the business under which the partnership shall be carried on is M/S "KAMINI KAUSHAL CONSTRUCTION".  
(ii) That the registered office of the firm shall at 13 , 2<sup>nd</sup> Floor, Kamani Centre , Bistupur , Jamshedpur- I , and it's Branch/ Site Office shall be at Dhanbad, it is decided that the firm may open one or more branch or branches for the smooth and expedient functioning of the business .



#### NATURE OF BUSINESS

3. That the parties will carry on the business of Civil Construction as Developer , Builder and Promoter and other Civil jobs ,which may be agreed upon by partners by mutual consent.

#### COMMENCEMENT

4. That the parties shall be deemed to be partners of the said firm and business with effect from 22<sup>nd</sup> day of December, 2018.

#### DURATION

5. That the partnership shall be at WILL and shall continue with the mutual consent of all the parties until dissolved.

#### CAPITAL & PROFIT SHARING RATIO

6. (a) That the partners shall contribute and invest capital as per their convenience and requirement of the firm. All expenses and required finance for carrying the business shall be invested by the parties as per their Profit and Loss Ratio or the same may be raised from any financial institution, other parties or their self investment.



- (b) The individual Partner may invest capital in excess of his/her Profit And Loss Ratio in the business, for which such partner or partners shall be entitled to get "Interest on Capital" from the firm. The capital of the partners shall carry the simple interest @ 12% per annum or as may be mutually agreed upon.
- (c) That all the partners shall be entitles to get salary/remuneration against his / her services, in the business and firm as per provision of Income Tax Act ,ore specifically defined U/s 40 (b) of the said act , on computation of Book Profit In their profit sharing ratio .

The remuneration payable to parties aforesaid shall be calculated at the percentage of the book profit for each accounting year in the following manner : -

- A) On the first Rs. 3,00,000 of the book profit Rs.1,50,000 or at the rate of 50% of the book profit  
in case of a Loss whichever is more
- On the balance of the book profit 60% of the book Profit

### DUTIES AND MANAGEMENT

8. For the following given clause and formalities 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> party are responsible either jointly or severally :

- a. That all papers, documents of the business including tender, quotation, bills, vouchers, challans, etc., shall be signed and placed by any partner for and on behalf of the firm.
- b. That the 1<sup>st</sup> party Shri Kaushal Kumar Singh, will act as Managing Partner in respect of and/or for and on behalf of the firm and business of partnership.
- c. That all employees, agents and workmen for the business shall be engaged by and dismissed with joint consent of all the partners or anyone acting through for and on behalf of the firm.
- d. That all the partners shall be fair and diligent for the business and shall work best for the interest and benefit of the firm.
- e. That all the partners, jointly or severally, shall collect all cheques, cash, draft and payments from all customer/s or any amount payable to the firm by any party and will deposit such amount or amounts with the existing account or accounts of the firm.

That the firm shall maintain proper and regular account with all vouchers, receipts, sureties, papers, etc. and such papers and documents shall be kept in the office of the partnership.

- g. That if any partner shall be desirous of selling his/her share in the partnership, he/she shall sell it to the other partner at a fair valuation.
- h. That the new partner or partners may be admitted in the Partnership, on the terms and conditions mutually agreed upon by the existing partners and also by the incoming partner or partners.
