## MEMORANDUM OF ASSOCIATION OF SRINATH HOMES INDIA PRIVATE LIMITED

- I. The name of the company is **SRINATH HOMES INDIA PRIVATE LIMITED**.
- II. The registered office of the Company will be situated in the State of Jharkhand.
- III. The objects for which the Company is established are:

# (A) THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION:

 To erect and construct houses, building, do civil construction work of all types, infrastructure work of all types and to purchase-take on lease, or otherwise, own, construct, effect, alter, develop, decorate, furnish, equip with all infrastructure, pull down, improve, repair, renovate, build, plan, layout, set, transfer, charge, assign, let out, sublet all type of plots, lands, buildings, bungalows, quarters, offices, flats, chawls, warehouses, colonies, godowns, shops, stalls, markets, malls, multiplexes, hotels, restaurants, banquet halls, houses, structures, constructions, tenements, roads, bridges, flyovers, underpasses, railway lines, dams, all kinds of agriculture infrastructure and infrastructure for waste land, refineries of all kinds, airports, seaports, telecom infrastructures, power houses, mines, lands, estates, immoveable properties of all types.

- 2. To carry on the business as owners, builders, colonizers, developers, promoters, proprietors and contractors, maintainers of residential, commercial and industrial buildings, colonies, mills and factory's buildings, workshop's building, cinema's houses and deal in all kinds of immovable properties whether belonging to the Company or otherwise.
- 3. To act as consultants for real estates, immovable properties and all types.
- 4. To carry on the business of town planners, Group Housing Developers, surveyors, valuers, appraisers and other building requisites.

# (B) OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS:

- To promote, encourage, establish, develop, maintain, organize, undertake, manage, operate, conduct and to run in India or abroad computer training centers, data processing centers, electronic mail, E-Commerce, E-business and internet applications, web site services, designing and hosting, cyber cafe and other allied activities of all sorts and services relating to computers, information technology, its maintenance, repair programs and operations for industrial, commercial, domestic public utility.
- 2. To run, manage, operate learning center, training center, education center, grooming center and to run institutes, centers for the Indian Languages, Foreign Languages and all related works including provide job oriented trainings, organize interviews on

behalf of other companies, and to act as placement agency and all related thins thereof.

- 3. To manufacture, fabricate and assemble all packaging media including tin cans, paper packing, card board boxes, bottles and all other type of containers required for any of the business carried on by the company or in connection with their advertising, marketing export or distribution.
- 4. To explore, prospect, take on lease or on royalty basis or other wise acquire mines, mining rights and lands or any interest therein and to quarry, mines dress, reduce, draw, extract, calcine, smelt, refine dispose of and deal in all types, qualities and description of ores, metals and mineral substances and carry on any other metallurgical operations which may seem conducive to any of the company's subjects.
- 5. To do research into all aspect of information technology in general field and/or in any specific assignments as may be entrusted to the company.
- 6. To do Construction, Erection, Testing, & Commissioning of Power Transmission/ Distribution Lines upto 220 KV & their operation & maintenance.
- To do Construction, Erection, Testing, & Commissioning of Power Sub Station upto 220 KV & Their operation & maintenance.
- 8. Electrical wiring of industrial, commercial and residential premises.
- 9. To do any other business (whether manufacturing or otherwise) which may seem to the company capable of being conveniently carried on in connection with the company's main objects or which may be advisable to undertake with a view to developing, rendering, valuable, prospecting or turning to account any property, real or personal, belonging to the company, or in which the company may be interested if so authorised by the main object.

- 10. To purchase, taken on lease or in exchange hire or otherwise any real and / or personal property and any rights or privileges, which the Company may think necessary or convenient for the purpose of its business or may enhance the value of any other property of the company and, in particular, any land (freehold, leasehold or other tenure), building, easement, machinery, plant and stock in trade and on any such land to erect buildings, factories, sheds, godowns or other structures for the work and purposes of the company and also for the residence and amenity of its employee staff and other workmen and erect and install machinery and plant and other equipment, deemed necessary or convenient or profitable for the purposes of the company and either to retain any property to be acquired for the purposes of the company's business or to turn the same to account as may seem expedient.
- 11. Subject to provisions of Section 391 to 394 of the companies Act, 1956 to amalgamate, enter into partnership or into any arrangement for sharing profits, union of interest corporation, joint adventure or reciprocal concession, or for limiting competition, with any person, firm of company carrying on or engaged in, or about to carry on or engage in any business or transaction which the company is authorised to carry on the engage in or which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company.
- 12. To borrow or raise money subject to the provisions of Section 58A of the companies Act, 1956 to receive money on deposits or loan at interest or otherwise in such manners the Company may think fit.
- 13. To lend and advance surplus money or to give credit to such persons or companies and on such terms as may seem expedient and in particular to customers and other having dealings with the company to guarantee the performance of any contract or obligation and the payment of money or by any such persons or companies.
- 14. To invest and deal with surplus money of the company in such manner as may from time

to time be determined.

- 15. To draw, make accept, endorse, discount, execute and negotiable bills of exchange, hundies, bills of lading, promissory notes, warrants debentures and other negotiable or transferable instruments or securities.
- 16. To provide and arrange for technical training, education aid and advice to any person in respect of any matter or problem connected with or incidental to the main business of company.
- 17. To own, purchase, charter, hire, contract, equip and maintain motor vehicles, cars, vans, vessels, tractors, warehouses, godowns for the purpose of the company.
- 18. To establish run and manage branches, showrooms and retail outlets anywhere in India or abroad.
- 19. Providing bio informatics and Biotechnology related services.

### (C) OTHER OBJECTS: -

- 1. To establish center for electronic Data processing, E.D.P. training center and to develop, design, make, invent, lease, sell, hire software packages and programmes for storing, processing and analysis of Data for accounting, pay rolls, inventory control and planning and/or any other data work for Bank, Insurance Companies, Electricity Boards, Railways, Airlines, other Government, semi-Government departments and other parties.
- To act as agents or representatives, of corporations, firms and individuals and to carry on and undertake any business undertaking transactions or operation commonly carried on or undertaken by commission agents, merchants, factors,

selling agents, importers and manufacturers, agents, insurance brokers, contractors and generally to undertake, transact and include all kinds of agency business and also trusts of all kind.

- 3. To deal with computer, data processing machines, types, cards, memory equipment, Hardware and Software or any other equipment and materials of every kind and description useful in connection with detection and prevention of forgery and frauds, Management Information Control Systems analysis and development, organization and management, statistical surveys and analysis, tabulation, compilation and declaration of results of every kind.
- 4. To explore, prospect, take on lease or on royalty basis or other wise acquire mines, mining rights and lands or any interest therein and to quarry, mines dress, reduce, draw, extract, calcine, smelt, refine dispose of and deal in all types, qualities and description of ores, metals and mineral substances and carry on any other metallurgical operations which may seem conducive to any of the company's subjects.
- 5.
