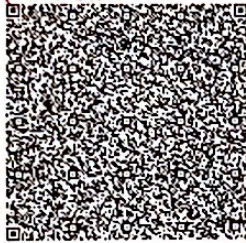

1. That the business of the partnership shall be carried in the name and style of " **RAMAS INFRATECH** " with its principal place of business at 354, New Layout, Sitaramdera, PO-Agrico Jamshedpur - 831009. The office may be changed with the mutual consent and as per business requirements.

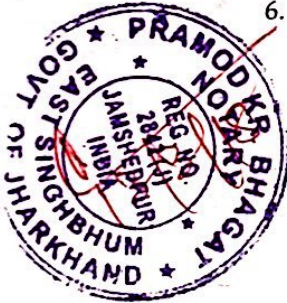

2. That the firm has been started and shall be deemed to started as on 12<sup>th</sup> of February 2018.
3. That the Partnership firm shall be formed for the purpose of the doing business of **PROMOTERS, DEVELOPERS & CONSTRUCTION works.**
4. That the necessary capital as well as further funds required for the purpose of the partnership business shall be contributed or arranged by the partners in such manner as may be mutually agreed upon by and between the partners from time to time. Interest @12% per annum or such lower or higher rate as may be prescribed by Section 40(b) of the Income Tax Act 1961 or any amendment thereof may be in force in the relevant financial year shall be payable to the partners on the amount standing to the credit of the account of the partners. Such Interest shall be credited to the account of each partner at the close of accounting year. Such interest may be lowered or waived, if so decided among the partners.
5. That all the partners hereof shall be working partners and shall be entitled for payment of yearly salary and remuneration at the rate of Rs 30,000/- per months for each partner. However where such total salary exceed the maximum permissible total remuneration specified in section 40(b) of the Income Tax act or any amendment thereof in that case the total yearly remuneration, shall be restricted to maximum permissible, in the section 40(b) of the act and shall be distributed amongst the partner in their profit sharing ratio. Such total salary may be lowered or enhanced as may be mutually decided amongst the partners from time to time.
6. That the Bankers of the partnership shall be such bank or banks as the partners may agree upon form time to time. It has mutually agreed that any two Partners out of above First Party, Second Party and Third Party, shall be jointly entitled to operate the bank accounts. That with mutual consent for the purpose of business the partners may arrange Loans and overdrafts from bank, financial institution or third party. The Partners may authorize any other person to operate the bank account.

8. That all the partners shall jointly manage and conduct the partnership business and employ themselves diligently and faithfully during the business hours and up to their best and utmost endeavors for beneficial promotion of the interest of the Partnership business.
9. That the terms of Partnership may be modified, altered or added to from time to time as may be mutually agreed upon new partners may be taken into Partnership on the terms and condition as may be mutually agreed upon.

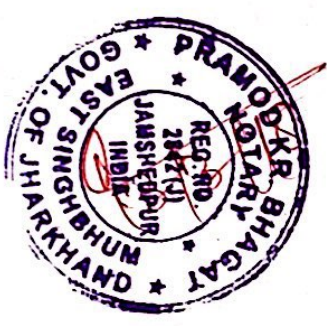
