10. That the firm shall maintain proper and regular account with all documents shall be kept in the registered office of the partnership firm.
11. That the Books of account of the firm shall be maintain according to English Financial years commencing 1st April and the Books of Account shall closed for the coming 31st March and the balance snee shall be prepared for relevant financial years.

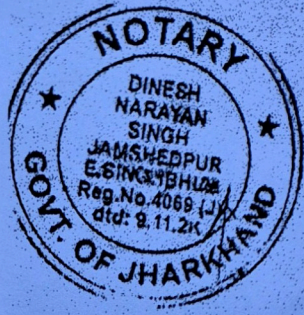
