



With reference to the revalidation application dated 12.11.2014 & consent letter No. Nil Dated 08.07.2015, the ADG(ER-I), CPWD, Kolkata is pleased to revalidate the enlistment w.e.f. 02.07.2015 of the following firm/Contractor in modified **Class - III Composite Category** of this Department as notified in the Department's Order noted against his/their name and address up to tendering limit **Rs. 1.5 Crore upto 31.03.2018**. The firm/contractor shall have to apply for next revalidation of enlistment in appropriate class of composite category before 31.03.2018 as per Enlistment Rule applicable at that time. The firm/contractor shall eligible to tender for CPWD works in the above category within the Region covered under the jurisdiction of ADG(ER-I) where this department has its organizations. however subject to meeting their eligibility criteria as laid down in the respective NIT or any further amendments thereof made from time to time without prejudice to the rights of the Department to prescribe/modify the limit of tendering.



- a) He/They shall be required to deposit earnest money with each tender as per terms and conditions of the Notice Inviting Tenders.
b) Security deposit will be recovered from his/their bill(s) in accordance with the rules in force from time to time
- He/They shall be required to continue to have a permanent Engineering Organization with at least minimum number of **Engineering Personnel and minimum Tools & Plants** as per provisions of Enlistment Rules 2005 & further amendments thereof made from time to time. You shall be required to intimate changes in your **Engineer Staff and/or Tools & Plants** as and when such changes are made. The firm/contractor has engaged **Sri Utpal Kumar Sen, Civil Engineer (B. E.)** as a permanent Engineering Staff at the time of revalidation/enlistment application.
- Contractor should possess valid Electrical License. The electrical license will also be kept renewed as per periodicity laid down by the authority concerned and submit an attested copy of the same to be enlistment authority after each renewal.

5. He/They shall employ the required **Technical Staff and/or tools & Plants** as per terms and conditions of each contract/agreement.
6. He/They shall have to abide by the terms & conditions of the NIT/Contract/Agreement as they/he stand or as may be altered from time to time.
7. He/They shall not modify the existing partnership or enter into any fresh partnership without prior approval of the enlistment authority. Such proposal if any shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/affidavit and documents as required. Any change in status of the contractor as an "individual" or in constitution of the firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from the approved list of contractors.
8. He/They shall be issued tender on production of valid electrical license from competent authority in the name of the contractor. However, the contractors shall be allowed to participate in tender with an undertaking that he/they will either obtain valid electrical license at the time of execution of electrical work or associate contractors having valid electrical license of eligible class.
9. He/They shall not be permitted to tender of works in CPWD Circle responsible for award & execution of contract, in which his/their near relative is posted as Divisional Accountant or as an officer between the grade of SE and JE (both inclusive). He/They shall also intimate to this **Directorate the name of the person who are working with them & who are near relatives** of any Gazetted officer in CPWD or in the Ministry of U.D. Any breach of the condition by the contractor shall render them liable to be removed from the approved list of contractors of the Department.
10. The enlistment notified in this order is valid **upto 31.03.2018** only. He/They will be required to apply for next revalidation of his/their enlistment before **31.03.2018** as per Enlistment Rules at the time in the prescribed form, along with all required documents.
11. He/They shall also intimate the change in his/their addresses (Registered Office/Head Office) if any, in future. In case he/they fail to intimate such change to the Department, his/their names shall be liable to be removed from the approved list of contractors.
12. It shall be mandatory for them to submit the performance report (PR) of each work executed by them in the approved format duly filled with all the required details to respective Executive Engineer within 3 months of completion of work under information to enlisting authority. In case they fail to do so, such work shall not be considered as eligible work for revalidation of enlistment.
13. The firm/contractor is required to secure works of required magnitude in the department. In case they/he fail/fails to secure works of required magnitude during the period of enlistment, the enlistment of the contractor is liable not to be revalidated.
14. He/They shall be bound by the Enlistment Rules of the Department as amended from time to time.
