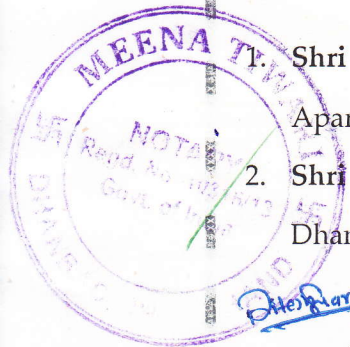

The existing partners of **Alokik Infra Build LLP** (hereinafter called LLP) mutually decided to reorganize the contribution of LLP by inducting Mr. Anurag Sharma as a Partner of the LLP and amend the LLP Original Agreement dated **6th Day of June, 2017** (hereinafter called LLP Original Agreement)

Whereas Shri Ashutosh Sharma, outgoing Partner in accordance with the Limited Liability Partnership Agreement (hereinafter LLP Agreement) and with the consent of existing partners assigned and transferred his entire beneficial ownership of LLP Partnership interest (right to receive profit or loss and distribution) in LLP to **Shri Anurag Sharma (Incoming Partner)**.

NOW IT IS HEREBY AGREED by partners as follows

Existing partners of the LLP consent to the conveyance, transfer, and assignment of the LLP Partnership Interest made by Assignment of LLP Partnership Interest (Copy annexed to this Agreement as Schedule A) and agreed that Shri Ritesh Kumar Sharma, Existing Partner has become a Designated Partner in the ALOKIK INFRA BUILD LLP, having, to the extent assigned, the rights and the powers of a partner, subject to the

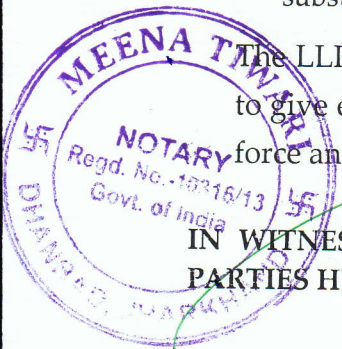

 - a. has been provided with a copy of the LLP Agreement,
 - b. has been given an adequate amount of time to review the LLP Agreement,
 - c. has read the LLP Agreement and understands that and all of its terms and conditions;
 - d. knowingly and voluntarily executed this Agreement; and
 - e. agrees to ceased be a Partner of the LLP and be bound by all the terms and conditions of the LLP Agreement,
4. The Schedule A –Part I & II (inserted vide Supplemental Agreement dated 13th January, 2018) of the LLP agreement shall be amended by deleting the table containing Name & Fathers name of the Partners, address, contribution towards Capital and profit sharing ratio and in its place, Name, Father's Name, Address, Contribution towards Capital and profit sharing ratio, table as given in the Schedule A to this agreement shall be substituted.

The LLP agreement shall as from the date hereof be deemed to have been modified to give effect to this Agreement and subject to such modification shall remain in full force and effect.
