ANNEXURE

The licence is subject to the following conditions :-

- (1) The licence shall be non-transferable
- (2) The number of workmen employed as contract labour in the establishment shall not, on any day exceed 20
- (3) Except as provided in the rules the fees paid for the grant, or as the case may be, for renewal of the licence shall be non-refundable
- (4) The rates of wages payable to the workmen by the contractor shall not be less than the rates prescribed for the Schedule of employment under the Minimum Wages Act, 1948, where applicable and where the rates have been fixed by agreement, settlement or award, not less than the rates fixed
- (5) In case workmen are employed by contractors in production or maintenance jobs which are not permanent in industrial establishments, the workmen will be paid the same wages and allowed the same facilities in respect of leave, holidays and hours of works, as are allowed to the workmen employed directly by the said establishment for the same or similar jobs. in case of disagreement about "the same or similar jobs" the matter will be referred to the Commissioner of Labour whose decision shall be final.
- (6) In other cases the wage rates, holidays, hours of work and conditions of service of the workmen of the contractor shall be such as may be specified in this behalf by the Commissioner of Labour, Bihar.
