- c) In the case of the Cash Flow Statement, of the cash flows of the Company for the year ended on that date.

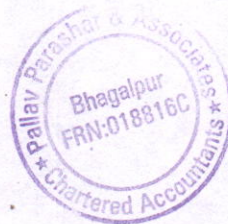





## **REPORT ON OTHER LEGAL AND REGULATORY REQUIREMENTS**
