## DEED OF PARTNERSHIP

(Hereinafter referred as First Partner);

SANDEEP KUMAR, (UID NO:- 2724 8266 8176) son of Shri Anil Kumar Sinha, by faith Hindu, by Ņationality Indian, by Occupation Business, resident of, Janta Market, Devnagar, Chhota Govindpur, Jamshedpur, District East Singhbhum, State of Jharkhand, Pin - 831015, (Hereinafter referred as Second Partner);

3. SAILESH KUMAR, (UID NO:- 8315 7355 1956)son of Shri Anil Kumar Sinha, by faith Hindu, by Nationality Indian, by Occupation Business, resident of, Janta Market, Devnagar, Chhota Govindpur, Jamshedpur, District East Singhbhum, State of Jharkhand, Pin - 831015, Jharkhand (Hereinafter referred as Third Partner);

WHEREAS Partners of this deed have Constituted a partnership firm under Partnership Act 1952 to establish the business in the line of promoter and developer, construction, plotting of land, real estate and sale, purchase etc. and the partners may enter into other varied ways of business as may be mutally agreed upon time to time, in the name and style of M/s. SHIVAY CONSTRUCTION having it office At 49, Devnagar, Chhota Govindpur, Jamshedpur- 831015. Vide deed of partnership dated 16th Day of December 2019. Now this deed witness that each of parties hereby convent with the other of them jointly by and severally in the following manners.

**AND WHEREAS,** the partners hereto as to avoid all litigations, misunderstandings and/or legal complications, if any of partners mentioned above including their legal heirs, voluntarily agreed to execute a proper Deed of Partnership dealing with their right, title, interest, claim, investment, business policy, banking operation, management and other affairs of the business and as to how the said business to be carried on in an efficient manner.

**AND WHEREAS,** it is thought desirable, necessary and expedient in the future interest of all partners that the terms and conditions governing their partnership should be reduced in writing.

NOW THIS DEED OF PARTNERSHIP WITNESSETH AND IT IS HEREBY MUTUALLY AGREED AS FOLLOWS:

- 1. That the name and style of the Partnership shall be "SHIVAY CONSTRUCTION"
- 2. That the business of Partnership shall be to carry on in India or elsewhere in the line of Prompter and Developer, Construction, Plotting of land, real estate, to Construct, deal, develop, buy, sell, lease, exchange, maintain, improve or otherwise acquire real estate, land, building and other properties of any type or description and rights to connected with the land and turn the same into account in any maintain, buildings, roads, paths, route, channel, roadway, bridges, flyovers, reservoirs, canals, drains, waterways, links, overpass, tunnels, passageway,

pathway, subway, highway, expressway, railways and to supply all kinds of construction materials and all types of infrastructure and all other works, erection and things of any description and as may be extended or restricted as the parties may decide from time to time.

- 3. That the partners shall be partnership at will and shall continue until determined by mutual consent of the partners. That the partnership commences and deemed to have always commenced from the date of execution of this deed.
- That the principle place of business of Partnership firm shall be situated at 49, Devnagar, Chhota Govindpur, Jamshedpur, East Singhbhum, Jharkhand - 831015.
- 5. The capital investment of the partnership business will be in the proportionate of

First Partner : 40%
Second Partner : 30%
Third Parner : 30%

Or as mutually decided by the partners

- 6. The partners will be sincere and faithful to this partnership business and will devote their whole time for smooth running of the business. No partner shall undertake any such, job, which may be detrimental to this partnership business.
- 7. That it is hereby agreed that in consideration of the parties of the First/Second/ Third partner who are actively devoting their time and attention to the business of partnership. They shall be entitled for remuneration as Computed U/s 40B of Income Tax Act 1961.
- 8. That the total remuneration payable in the accounting year in which the partnership firm has made inadequate profit/suffer losses that Rs.25000/- to each partner.
- 9. That the partners are entitled to get interest @ 12% per Annum form partnership on capital contributed by them for the purpose of running of business.
- 10. That the funds required for the purpose of the partnership business shall be contributed or arranged by the partners in such manner as may be mutually agreed upon interest @ 12% per annum simple interest or such lower / higher rate as may be prescribed under section 40(b) (iv) of the Income Tax Act 1961, or any other applicable provision as may be in force for the income tax assessment of the partnership firm the relevant accounting period shall be payable by the partnership on the amount standing to credit of capital.

12. That the partners of this deed will be entitled to get profit and bear loss (if any) in the following ratio.

The party of the First partner : 40%
The party of the Second partner : 30%
The party of the Third partner : 30%

- 13. That a Bank Account (Current Account) shall be opened in the name of partnership firm in one or more nationalized or other bank, and same shall be operated under the joint Signature of **Ajay Kumar** (the first partner above referred) and **Sandeep Kumar** (the Second partner above referred), on behalf of partnership firm.
- 14. That the proper book of accounts of partnership shall be maintained and shall be kept in office to have access and to inspect and take extract there from by all the partners. The accounts shall be closed on every 31st March of the year.
- 15. The Partners of the firm shall devote their time and attention to the business of the partnership diligently and faithfully employ themselves there in and use their best skill and endeavor to carry on the same for the utmost benefit of the partnership
- 16. The firm now constituted under these presents shall not be liable for any debt or liability contracted or incurred by any of the partners in his/their personal capacity and not for by any of the purpose and benefit or the present partnership business without the previous consent in writing of other partner.
- 17. That the partners shall be just and faithful to each other of them in all matters, relating the partnership and shall not do or cause to be done anything which may harm the interest of the partnership.
- 18. That if any partner or partners desires to retire, he may be allowed to do so after giving one month notice in writing to either of them. In such event, the other partners may continue the business, by himself/themselves or admitting some other parson or persons as partners.
- 19. That the partners may be allowed to withdraw from time to time of such sums from the partnership funds, as may be mutually agreed and all such shall be debited to the personal account of the respective partners.

- 20. That each or any one partner shall be deemed to be authorized on behalf of the partnership to enter into any agreements or to submit tenders to receive payments and give due discharge whereof.
