



The Annexure referred to in our Independent Auditor's Report to the members of the Company on the standalone financial statements for the year ended 31 March 2022, we report that:-

- (i) (a) The Company has maintained proper records showing full particulars, including Quantitative details and situation of fixed assets.
  - (b)The Company has a regular programme of physical verification of its fixed assets. bywhich fixed assets are verified in a phased manner over a period of three years. Inaccordance with this programme, certain fixed assets were verified during the year and no material discrepancies were noticed on such verification. In our opinion, this periodicityof physical verification is reasonable having regard to the size of the Company and thenature of its assets.
- (ii) The Company is a service/ Goods SupplyCompany, primarily rendering services and further selling of foods products. Accordingly, itholds physical inventories. Which is taken in books, as certified by the management.

That, the Cash was not physically verified by us, rather it was certified by Management and accordingly taken in Books of accounts.

- (iii) (a) The Company hasgranted loans to bodies corporate covered in the registermaintained under section 189 of the companies Act ('the Act').
  - (b) If in the case of the loans granted to the bodies corporate listed in the registerMaintained under section 189 of the Act, the borrowers have been regular in thePaymentof the interest as stipulated. The terms of arrangements do not stipulateany repayment schedule and the loans are repayable on demand.
