5. That, all partners will take benefits and will bear loss as per the ratio shown in the capital investment column i.e.

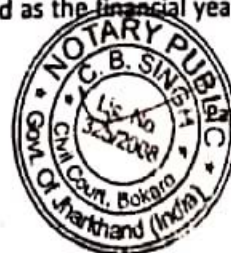
