**MEMORANDUM OF ASSOCIATION**

**OF**

**ECONAVI BUILDTECH PRIVATE LIMITED**

- I. The name of Company is ECONAVI BUILDTECH LIMITED.
- II. The registered office of the Company will be situated at the Jharkhand.
- III. The Objects for which the company is established are as follows:

**(A) THE MAIN OBJECTS TO BE PERSUED BY THE COMPANY ON ITS INCORPORATION ARE :-**

1. To enter into the business of real estate developments ,construct, build, take on lease, or acquire in any manner whatsoever any property, apartment, house, flats, shops, offices, clubs, township, markets or other buildings and for these purpose to purchase take on lease or in exchange higher or otherwise acquire and hold any land any prepare layout there own to construct, reconstruct, prepare, pull down, alter, improve, decorate, furnish and maintain flats, dwellings, houses, shops, offices, clubs, residential plots etc to equip the same or any part there of with all or any amenities or conveniences, drainage, facilitates, electric, telegraphic, telephone, television installation to install sanitary convenience of all kinds, garages and procreation facilitates, to let out or dispose of the same on installments basis, rent basis or by outright sale or any other mode of disposition, to collect rent and income, drainage water, electric and other charges from tenants, occupiers and others, and to deal with the same in any manner whatsoever. To manufacture and acquire and deal in any and every kind of article and products and material used for buildings or allied objects whether for companies on use or for sale and disposal.

**(B) THE OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS STATED IN CLAUSE ABOVE (A) :-**

1. To enter into agreement, arrangement, joint venture, collaboration, syndication, consortium, partnership or any other arrangement with central government, state government, local authority, statutory body, company, firm, individual and or otherwise with any other person or entity whether for sharing profit or for cooperating or reciprocal concession or for license or otherwise and promoting a new business unit for manufacturing, owing, building, developing, maintaining,

- operating, running, leasing, transferring, caring on engage in or about to carry on engage in any business or transaction which this company is authorized to carry or engage in any business or transaction capable of being conduct so as the to benefit this company and to give with any special right, license and privileges in connection and in particular the right to nominate one or more person or persons whether they be shareholders or not, of the company.
2. To import and purchase any machinery, implement, parts, equipment, materials, articles to do all things for attaining the main objects of the company.
  3. To act as consultants and to advise and assist on all aspects of corporate, commercial and industrial management or activity including production, manufacturing, personnel advertising and public relations, public welfare, marketing, taxation, technologies, insurance, purchase, sales, quality control, computer applications, software, productivity, planning, research and development, organization, import and export business, industrial relation and management and to make evaluation, feasibility studies, project reports, forecast and surveys and to give export advise and suggest ways and means for improving efficiency in mines, trades, plantations, business organizations, cooperative societies, partnership and proprietary concern and industries of all kinds in India and else where in the world and improvement of business management, office organizations and export management to supply and provide, maintain and operate services, facilities/conveniences, bureau and the like and to recruit and/or advise on the placement/recruitment of staff.
  4. To carry on the business of broker, sub - broker, jobbers, agents, dealers, merchant of all type of commodities, grams, nuts and other items as may be permitted by the commodity exchange in India and to deal in future and options and in other derivatives as a member of commodity exchange in India and to carry on all or any of the business of buyers, sellers, traders, distributors, heirs, indenters, assemblers, packers, processors, warehousemen, merchant, agents, brokers, sub brokers, stockiest, commission agents, and dealers of salt, raw jute, hemp, jute fibers, rope and lining, jute cloth, and all other kinds of jute product, hessian and gunny products. Textile, readymade garments, natural yards, hosiery, mixed fabrics, artificial and natural fabrics, fodder bran, fruits, nuts, cashew nuts, kernels grains, pulses, spices, flour, tea, coffee, sugar and molasses, oil and cakes, vanaspati, vegetable products.
  5. To construct, build, take on lease, purchase or acquire in any manner whatsoever any apartment, house flats, shops, offices, clubs, township, markets, or other building and for these purpose to purchase take on lease or in exchange, hire or other building and for these purpose to purchase, take on lease or in exchange. hire or otherwise acquire and hold any land and prepare layout there own, to construct, reconstruct, prepare, pull down, alter, improve, decorate, furnish and maintain flats, dwelling houses, buildings, shops, offices, clubs etc , to equip the same or any part thereof with all or any amenities or convenience, drainage facilities, electric, telephonic, telephone installation, to install sanitary convenience of all kinds, garages and recreation facilities, to let out or dispose of the same on installment basis, rent basis or by outright sale or in any other mode of disposition, to collect rents and incomes, drainage water, electric and other

charges from tenants, occupiers and others, and to deal with the same in any manner whatsoever, to manufacture and acquire and deal in any and every kind of article and products and materials use for building or allied objects whether for companies on use or for sale and disposal.

6. To purchase, take on lease or in exchange, hire or by other means acquire or option over any freehold or any other property for any estate or interest whatsoever any rights, privileges or assessment over in respect of any property buildings, factories, mills, works, wharves, roads, machineries engines ,transport vehicles ,rolling stocks plants live and dead stock or things and any immovable property or rights which may be necessary convenient for the purposes of the business of the company or may enhance the value of any other property of the company.
7. To undertake financial and commercial obligations , transactions and operations for achievement of the main objects of the company
8. To carry on the investment business and to purchase ,acquire ,hold and dispose off or otherwise invest and deal in shares ,debentures ,stocks, bonds ,units ,obligations and securities issued or guaranteed by any company constituted or carrying on business in India or elsewhere and debentures ,bonds units ,stocks, obligations and securities issued or guaranteed by any Government , state dominion ,sovereign, ruler, commissioner, public body or authority ,supreme municipal ,local or otherwise whether in India or elsewhere and to act as investors guarantors, financiers to industrial enterprises either out of its own funds that the company might borrow by issue of debentures or from bankers or otherwise howsoever in any other manner
9. To draw ,make ,accept, endorse , discount , negotiate, execute and issue bills of exchange ,promissory notes ,and bill of landing ,debentures and other negotiable or transferable instruments or securities .
10. To undertake and execute any trust any trust which may be considered to be benefit to the company directly or indirectly for the purpose of the business of the company.
11. To carry on the business of hoteliers, restaurant, dhaba by acquiring assets in its own name or taking the assets on lease, rent or taking franchisee of any brands or enter into any partnership or joint venture with any individual or firm or any company registered either in india or outside india.
12. To sell, exchange ,mortgage ,let on lease ,royalty or tribute grant, licenses ,easements, options and the right over and in any other manner deal with or dispose of the whole or any part of the undertaking property ,assets rights and effects of the company for such consideration as may be thought fit and in particular for stocks, whether fully or partly paid up or securities of any other company.
13. To lend and advance money , out of surplus fund of the company not immediately required, either with or without security and give credit to such persons or (including government) and upon such term and conditions as the company think fit but not amounting to banking business as defined by the banking regulation act, 1949.

14. To guarantee the payment of money unsecured or secured or payable under or in respect of promissory notes, bonds, debenture stock, contracts, mortgages charges, obligation, instrument and securities of any company or of any authority, supreme, municipal, local or of any persons whatsoever, whether incorporated or not incorporates, and generally to guarantee or become sureties for the performance of any contract or obligation as may be necessary for the purpose of the company.
15. To pay for any right or property acquired by the company and to remunerate any person, firm or body corporate rendering services to the company either by cash payment or by allotment to him or them of share or securities of the company as paid up in full or in part or otherwise.
16. Subject to the provision of law in force and rule framed there under and directive issued by R.B.I for the time being, to receive money on loan and borrow or raise money in such a manner as the company shall think fit, and in particular by the issue of debenture or debenture stock perpetual or otherwise and to secure the payment of any money borrowed, raised or owing by mortgage, charge or lien upon all or any of the property or assets, of the company (both present and future), including its uncalled capital, and also a similar mortgage, charge or lien to secure and guarantee the performance by the Company or any other person or Banking as the case may be, but not amounting to banking business as defined by the banking regulation act, 1949.
17. To accept donation, gift, grant-in-aid, endowment of moveable property and immovable properties from any person or persons, Government, Municipalities, District and local bodies, public bodies or any other person or persons or societies or companies or firm on such term or terms as may be considered fit and proper.
18. To subscribed for, underwrite acquire, hold and sell shares, shares- stock, debenture or debenture stock, bonds, obligation, securities of any kind issued or guarantee by the company (body corporate or undertaking) of whatever and whatsoever constituted or carrying on business and to subscribe for underwrite. acquires, hold and sell shares debenture or debenture stock, debenture bonds, obligation, mortgage, and other securities issued or guaranteed by the bank, by any Government, sovereign ruler, commissioners, trust, municipal, local or other authority or body of whatever nature, whether in India or elsewhere as may be conducive to the business of the Company.
19. Subject to section 58A, and 292 of the Act, and the regulation made there under and the directions issued by reserve Bank of India, to received money on deposit or loan and borrow or raise money in such manner as the Company shall think fit and in particulars by the issue of debenture or debenture stock (perpetual or otherwise) and to secure the payment of any money borrowed, raised owing or the mortgage, , charge or lien upon all or any of the property or assets, of the company (both present and future), including its uncalled capital, and also similar mortgage, charge or lien to secure and guarantee the performance by the Company, of any obligation undertaken by the company.
20. To apply for, purchase or otherwise acquire and protect, prolong and renew in all part of the word, any patents, patent right, brevets, inventions, trade mark designs, license, protections, concessions, and the like conferring any exclusi

- or non-exclusive or limited right to their use or of any secret or other information as to any invention, process or privileges which may seem capable of being used for any of the purpose of the company or the acquisition of which may seem calculated directly or indirectly to benefit the company and to use ,exercise ,develop or grant licenses or privileges in respect of or otherwise turn to account ,the property ,rights and information acquired and to carry on any business in any way connected therewith .
21. To spend money in experimenting upon and testing and in improving or seeking to improve any patents ,rights ,inventions discoveries ,processes of information of the company which the company may acquire .
  22. To procure the registration or recognition of the company in or under the law of any place outside India.
  23. To form ,incorporate or promote any company or companies whether in India or elsewhere having amongst its or their object the acquisition of all or any of the assets or controls , management or development of the company or any other objects which in the opinion of the company could or might directly or indirectly assist the company in the management of its business or the development of its properties or otherwise prove advantageous to the company and to pay all or any of the costs and expenses incurred in connection with any such promotion or in corporation and remunerate any person or company in any manner it shall think fit for services rendered or to be rendered in or about the formation or promotion of the company or the conduct of its business or in or about the promotion of the company in which the company may have an interest.
  24. Subject to the provision of section 391 to 394 the companies act ,1956 to amalgamate, or enter into partnership or into any arrangement for sharing profits ,union of interest ,co- operations , venture or reciprocal with any business which the company is authorized to carry on.
  25. To enter into any arrangement and take all necessary or proper steps with governments or with other authorities ,supreme ,national ,local ,municipal or otherwise of any place in which the company may have interest and to carry on any negotiations or operation for the purpose of directly or indirectly carrying out the objects of the company of effecting any modification in the constitution of the company or for furthering the interest of the members and to oppose any such steps taken by any other company ,firm or person which may be considered ,likely ,directly or indirectly to prejudice the interest of the company or its members and to assist in the promotion whether directly or indirectly of any legislation which may seem advantageous to the company and to obtain from any such government authority and company any charters ,contracts ,decrees ,rights ,grants ,loans ,privileges ,or concessions which the company may think it desirable to obtain and carry out ,exercise and comply with any such arrangements ,charters ,decrees rights, privileges or concession.
  26. To carry any scientific research or other research which may be of benefit to the company and to establish, conduct and carry on any educational or other institutions and research or such other activities for the attainment of the main objects.
  27. To pay for preliminary and pre-incorporation expenses of the company.

28. To grant allowances, salaries, gratuities, pension and bonuses to employees of the company or dependents of such person and to support and to subscribe to any provident or benefit fund for the employees of the company or any other company under the secretary ship of the company or management of the company.
29. To do all or any of the above things either as principle. Agents, trustee, contractors or otherwise and either alone or in conjunction with other and either by or through agents sub contractors, trustees and otherwise.
30. To acquire and undertake all or any part of the business , property suitable for the purpose of the company.
31. To adopt such means of making known the business of the company as may seem expended and in particular by advertising in the press, circulars, by purchase and granting prices, rewards and donations.
32. To subscribe or guarantee money for any national, charitable, benevolent public or general or useful object or for any exhibition, subject to the provision of section 293 of the act.
33. To distribute amongst the members in specie or other wise any property of the company or any proceeds of sale or disposal of any property of the company, in the event if its winding up but so that on distribution amounting to a reduction of capital of made aspect with the sanction (if any) for the time required by law.
34. To do all such other things as may be deemed incidental or conducive to the attainment of the above objects or any of them.
35. Raise Capital.

**(C) OTHER OBJECTS FOR WHICH THE COMPANY IS ESTABLISHED ARE:-**

1. To carry on the business of farming, horticulture, floricultural, sericulture, dairies, cultivators of all kinds of food grains, seeds, fruits, proprietors of orchards and traders, exporters, dealers, and sellers of the products of farming dairy, horticulture, floriculture, sericulture, and pisciculture and fishing and manufacturers of drinks, alcoholic or otherwise, cultivators, growers, manufacturers, millers, grinders, rollers, processors, cold stores, canners, and preservers and dealers of food grains and other agriculture, dairy, horticultural and poultry products, fruits, vegetables, herbs, medicines flowers, drinks, fluids, and other fresh and preferable products, and to extract by-products and derivatives whether edibles, pharmaceutical medicines of any other kind or nature whatever and food preparation of every kind and description and generally the business of manufacture of and trading in preserved, dehydrated, canned or converted agriculture products, fruits and vegetables, foods dreary and poultry products and articles and other processing and preserving the same.
2. To carry on the business as manufacturers of or dealers in glass products Including sheet and plants glass, optical glass, glass wool, laboratory ware and thermometers.
3. To undertake and transact all kinds of agency business and to and promote any business, commercials or otherwise, under sound principals and or to act as distributors, agents underwriters brokers estate agent middleman contract man



representation and indenting agents on commission allowances as may be deemed fit all commodities, merchandise and other allied articles/ lines of business.

4. To carry on the business of papers, computer papers, offices equipments, lather goods, sports goods, toys, writing instruments, cooking ranges, light products, cosmetics, stones, foams, glasses, earth moving products, automobiles, artwork, handicrafts, paintings, industrial goods, intermediate products, raw materials, spare parts, finished goods, commercials goods etc.
5. To carryon the business of all types of transporters, couriers, messengers, deliveryman, carriers whether by person, motor lorries, motor cars, station wagons, motor bikes, bullock carts, steamers, ships, barges, boats and all means of transport, steam and oil engines, motor buses, aero planes and to carry goods, passenger, cargo, livestock's, fresh goods and other merchandise by mode of transportations.
6. To carryon the business and mechanical engineers, founders of iron and steel and ferrous and non-ferrous metal, tool makers, brass founders, boiler makers, machinist, iron and steel converters, builders, metallurgist, smelters, galvanizers, electroplaters, enamellers, water supply engineers, gas makers and to run work shops and to undertake and execute machinng/machinicaland structural jobs and to manufacturers, import, export, buy, sell, let on hire, exchange, alter, improve, manipulated, prepare for market and/or otherwise deal in or distribute minerals, plants, machineries, tools, implements, rolling stock, hardware, electrical apparatuses, machinery parts, utensils, chemicals, raw materials and substances and to carryon the business as technical consultants, advisers, assessors, designers, draftsman, operator, inspectors, surveyors and valuers.
7. To carryon the business of fire detection and fire fighting systems, equipment and accessories, fire extinguishers, fire-proof materials, articles and apparels, smoke detection equipments Hydrants, Sprinklers, Foam, Fire Mastic, Coatings, Fire Barriers Devices for Extinguishing fire, Dry chemicals and powder, proofing, Fire plug, fire bridge, fire proof curtains, fore walking systems, Anti-fire chemicals and equipments, medicines for treatments of fire, Water, Helmets and to render all kinds of services and to managements and supply, installation and servicing of all types of fire Detection and protection systems and other matters related thereto and also to act as Fire Control Engineers, Fire detectives and investigators and organizers for fire safety training courses and to give all kinds of assistance in putting off, fire and rescuing and giving medicals and/or other helps to those in fire.
8. To carryon the business of all kinds of plastic, PVC, fittings colours, chemicals containers, extracted products, fabrication, Film tubes, Sheet , Bags injection mouldings accessories, moulded components, Moulded goods ,moulds, processing equipments, Plastic products and all other allied items.

9. To carry on the business in all kinds of electrical, electronic including its spares, component, accessories, equipments, appliances, fittings, heating and cooling systems, refrigeration items, stamping, lamination materials, switches, transmission line goods, solar, wind and thermal energy goods computers, computers hardware and software items, entertainments equipments, plastic- blow moulders, containers, tapes, mouldings, plastic fabrics, audio and video products, circuits, transmitters, transformers, photographic items batteries, chargers, time keeping devices, projectors, all consumer goods related with electrical, electronics and plastic, boxes, pollution control systems, washing systems, and devices, cooking ranges, lighting systems, wireless apparatus, tape recorders, broadcast, relay and reception equipments, audio and visual communications, electronic cum electrical control systems and implements.
10. To carry on the business of stones, marbles, chips, powders, clay, gravel, fuel, mines and minerals, artificial, stones, dust, diamond stones, instruments, idols, plasters, whitening, mortars, boulders, bricks, sands tiles, refectories, china wares, sanitary materials, pipes, tubes, structures, granular, crystalline limestone, rocks, slabs, tombstone, tomb, colour, marble-cutter, cement, paints, adhesives, sheets, roofing, glasses, furniture, fittings, water-supply or storage tanks bathroom fittings, decoration items, statues, images, objects, d'art sign boards, name plate, floors, concrete mixtures, diosers, timber, teak, board, rubberized paper, chemicals, museum items, curios, antiques, toys, stationeries, novelties, rubber goods, chemicals, tools detonators, explosives, oils, implements, gas cake, coal, water, minerals, substances, masonry works, all kinds of building and construction materials, iron, charcoal, makrana, sangmarmar, seer of marble, hammers, hand chisels, potteries, porcelain, wares, insulators, utensils etc.
11. To carry on the business of and taking and providing on hire and or on any other business arrangement basis in all kinds of cranes, overhead cranes, under slung cranes, truck, mounted cranes, Goliath, Earth moving machinery and parts, all kind of vehicles or other modes of transportation whether through land, water, air or otherwise, industrial elevators, Forklifts, Caterpillar, Bulldozers, Crawler, Excavators, implements, heavy duty electro lifts, material handling and lifting equipments and devices, jigs, towers, power/electrical/manual winches, conveyors, skip hoists, engineering items, chain pulley, blocks, electrical wire rope/chain hoist, construction equipments, conveyor and bucket elevator, hoists, motorized Tray Trolleys, Mining equipment, Air, Gas, tools, consumable items, drilling and Boring Equipment, Helmets, Pneumatic, Equipment, Safety and clothing Equipment, Dust Respirator, Under ground drilling rigs.
12. To carry on the business of engineering, galvanizers and fabricators of structures metals or materials, parts of structures, fabricated structures, towards, M.S. foot bridge, steel foot trough pressed steel tanks, P.S. tanks and staging, M.S. tanks Tubular structures, M.S. plate, steel partition, door and windows, temporary houses, shelter, fabricated houses, mobile houses, galvanization of various

products, rolling items, steel aluminum or any other kind of door, window, false flooring, false ceiling, iron removal plants, sleeper bunks and its parts, steel roof trough frames, iron and steel and to act as moulders, forgers, rollers and re-rollers, iron-mongers. Smith, iron-founders, brass-founders, metal-workers, mill-wrights, machinists, iron and steel converters, processors, platers, casters, welders, jappers, turners, wood-workers, boiler-makers, fitters, joiners, painters, annealers, enamellers.

13. To carry on the business of distribution supplying, buying, selling, dealing, exporting, importing, assembling, repairing, servicing and marketing of all kinds of Domestic appliances and Personal care products, consumer goods, consumer communication & Electronic products, Home and kitchen products and appliances, consumer durables, public utility goods, radio sets, Tape recorder, Compact Disc players/ systems/combination sets, television receivers, public address systems, lamps, light products, batteries, Energy saving devices, lightings, midi systems, Head phone stereo, watches, musical clocks, time pieces, solar systems, components, calculators, telephones, wireless and cordless systems, computers, security items and systems, cameras, semiconductors, Mixer Grinders, steam and dry iron, Toasters, hair dryers, mobile handsets, entertainments electronic products, toys, information technology, Telecom & communication items, Electronic measuring instruments, fittings, PCB, broadcast systems, projectors, Display systems, UPS, Voltage stabilizer, home cinema Audio-Video, electrical, electronic and mechanical goods, refrigeration systems, office equipment, video games writing instruments, cooking ranges, fire fighting systems, and all other components, accessories, spares, equipments, devices, tools and to act as agents, indenting agents, clearing and forwarding, representative, market researchers, assemblers, products launchers, information and news passers, contractors, distributors, stockiest and suppliers.
14. To carry on the business as producers, distributors, importers, exporters, exhibitors of cinematography films, and to manufacture, own acquire, provide, secure, arrange or deal in films and photography, sound recording, musical, lighting appliances, instruments, equipments and machines and to construct, establish, own hire, or otherwise acquire and to manage, let out for rent, fee monetary gain or otherwise studios, laboratories, theaters, building open air theaters, bars, restaurants, and other buildings or work required for the purpose of production, distribution or exhibition of the films, operas, stage plays, dances, promenade, concerts, circus or other performances and entertainments, and to act as dealers, importers exporters of musical instruments and records, tapes, cinema and films projectors and cameras, wigs and other products or material related or connected with the aforesaid objects and business; and to acquire exclusively or limited rights to any play or story, script, musical songs and lyric, book, article or any technique by producing, purchasing or otherwise acquiring and to the Company; and to act as agents for training, retaining, arranging and supplying artist, stars, art directors, script or story writers technicians, extra and other personal required by the Company or other for film Cinema or business.

IV. The Liability of the members is limited.

V.
