Statutory return in Form 12(R), 10,5 etc. are to be submitted by 25th of the following month. It may please also be noted that damages are liable to be levied on all belated payments which may extend to 100% of the arrears as per the amended provisions of the Act with effect from Ist November 173.

Over and above, employers are required to furnish the particulars of ownership from 5-A in accordance with the provisions of para 36-A of the employees' Provident Fund and Family Pension Fund Scheme, 1952. Hence, you are directed to furnish the said a Form in duplicate duly falled in by Registered Post.

In case of any change in the particulars of Form 5-A the intimation showld be communicated to this office within 15 days of such change.
