AND WHEREAS, the retiring partner expressed his desire due to lack of fund to retire from the said partnership firm with effect from the day of executing this Re-constitute of Partnership Deed and also requirement of new partner for the said firm, the existing First partner has decided to introduce new partner to raise capital from the new partner and hence introduce Second Partner / Second Party, hence reconstituted the partnership deed on the following terms and conditions:-


NOW IT IS AGREED BY AND AMONG THE PARTIES HERETO AS FOLLOWS:

1. NAME OF THE FIRM:-

That the name and style of the firm is and shall continue to be "M/S. HIGH VISION REALTY" or such other name as the parties hereto may mutually decide from time to time.

2. PLACE OF BUSINESS/PROFESSION:-

That the office of the partnership shall be at- H.No. 477, Road No.-01, Tripurari Colony, P.O.-Adityapur, Dist- Seraikella-Kharsawan, Jharkhand-831013 and at present office at High Vision Tower, Kashidih, P.O. and P.S. Sakchi, Town Jamshedpur, District East Singhbhum, State Jharkhand or such place as may be mutually agreed to upon by the partners from time to time. The partners have agreed that branch/es may be opened at any other place on their mutual agreement and the some may be closed as and when the partners mutually agreed to from time to time and subject to Rules and Regulation.



3. BUSINESS/PROFESSION

That nature of business shall be - Development of Real Estates & Civil Constructions etc. and/ or other business or businesses that may be mutually agreed upon by and between the partners from time to time by the First partner and Second Partner.

4. DATE OF RECONSTITUTION

That the Partnership firm shall be deemed to come in force with effect from 15.01.2021 and the partnership as evidenced by these presents shall deemed to have reconstituted, first partner is existing partner and second partner is the new partner and third party is retired from the said partnership firm with effect from the date of execution of this Deed.

5. DURATION


That the partnership has come into effect from 15.01.2021, the duration of Partnership is Partnership at "Will" and can be dissolved as and when decided by the partners hereto mutually.

6. CAPITAL

The Capital Partnership firm shall be contributed and/or arranged by partners as mutually agreed upon from time to time and according to their convenience. The Partners may arrange additional capital by way of borrowing from Banks, financial institutions and outside parties at the rates and terms as may be mutually agreed upon by the parties hereto.

7. BORROWING

The partnership shall be entitled to raise and/or borrow loans from other parties namely individuals, firm(s), Body corporate(s), Bank(s),



financial institution on such terms and conditions as may be agreed upon between the firm and such lending parties. In that event anyone or all the parties hereto shall jointly or severally execute or sign the documents or papers as may be required in this behalf between the firm and the said lending parties,

8. REMUNERATION TO WORKING PARTNERS

That each partner shall be entitled to draw a salary as mutually agreed upon between them from time to time and the amount shall be in accordance of the provisions of the Income- Tax Act 1961 U/s 40(b).

9. SHARING OF PROFIT AND LOSSES

That the profit or loss of the partnership firm shall be shared by them in following ratio:-

10. BOOKS OF ACCOUNTS


That the books of account and all other records of the Firm shall be kept at the principal place of the firm or at such other place in India as may be mutually decided by the partners.

11. ACCOUNTING YEAR

That the partnership shall maintain regular accounts for its profession. The accounting year of the firm shall commence from the 1st day of April every year and ended with 31st day of March of every year.

12. FINAL ACCOUNTS

13. BANK ACCOUNT

That the bank accounts in the name of the partnership firm may be opened maintained and closed with such bank(s) as the parties hereto may from time to time decide and the same shall be operated by any one or survivor or otherwise as the partners may from time to time decides.

14. MANAGEMENT & CONDUCT OF BUSINESS


That the business of the firm shall be managed and conducted by the parties hereto with joint responsibility or as may be fixed between the parties from time to time.

15. POWERS & DUTIES OF PARTNERS

That every partner shall have authority in the emergency to do all such acts for the purpose of protecting the firm from loss.

None of the partners shall have the right to encumber profession and/or assets of partnership for personal debts and/or shall not be entitled to do any one or more of the following acts or things without





17. DEALING WITH GOVERNMENT DEPARTMENTS

That each partner is the agent of the partnership firm and as such each and every partner shall deemed to be authorized to sign and execute all or any official papers, forms, negotiable instrument, agreement, contracts, documents and deeds etc. apply for licenses, registration and permission in the name of the partnership firm in respect of which said partnership firm may be interested whether with banks, corporate bodies, courts of law, any judicial, revenue or administrative office or officers, Mercantile firms, State Government, Central Government departments etc. in connection with the business of the partnership firm and all such acts, deeds and things done or cause to be done by anyone of the partners shall be deemed to have ratified by all the partners.

18. RETIREMENT:

If any partner retires from the partnership an account will be made of the assets and profit or losses of the Firm since the end of the last accounting year till the date of retirement and his/her share therein will be ascertained and the same will be paid to him/her in lump sum or in such installments as may be agreed upon or in the absence of agreement as the majority may decide.

19. ADDMISSION:

That a new partner may be admitted with the mutual consent of both the partners.

20. EFFECTS ON DEATH, INSOLVENCY OR RETIREMENT


That the death (God forbid), insolvency or retirement of any of the partner or partners shall not dissolve the firm but it shall continue with the surviving or remaining partners. 21. DISSOLUTION

24. GOODWILL

That the partners shall be entitled to share the value of the Goodwill in their respective profit sharing ratio either in cash or in any other manner as may be mutually agreed upon and that the value of Goodwill of the partnership firm shall be computed as per mutual agreement.


25. SAVINGS:
