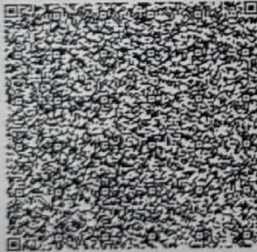

3. SMT. VINITA SRIVASTAVA, wife of Sri Santosh Kumar Srivastava, by faith Hindu, by occupation Housewife, resident of Jagjiwan Nagar, New Colony, Jagjiwan Nagar, Dhanbad 826 003, PO Dhanbad & PS Saraidhela, District Dhanbad, hereinafter called the Party of the Third Part.

2. That the partnership business shall be that of the business of real estate developers, builders, real estate agents, buying and selling of land and/or building and/or any property whether by of plotting or otherwise, renting out land and/or building and/or property, construction of building, schools, hospitals, roads, bridges, dams, malls, theatres, multiplexes, residential cum shopping complexes, whether by self or through contractors or on conversion basis or any other mode, and the like and such other business or businesses as mutually agreed to amongst the Partners from time to time
3. That the principal office of the partnership firm shall be at New Colony, MeeraBhawan, Jagjiwan Nagar, Dhanbad 826 003, PO Dhanbad, PS Saraidhela and at such other place or place as the parties may from time to time decide by mutual agreement.

4. That the Partnership shall be deemed to have commenced on Fifteenth day of January, Two Thousand Sixteen and shall be a partnership AT WILL.
5. That the Partners of M/s. MAA SHYAMA BUILDERS, the Firm, shall execute a Registered Power of Attorney in favour of the Party of the First Part, Sri. SANTOSH KUMAR SRIVASTAVA, on behalf of the Partnership business, duly authorizing him to execute all such acts, deeds and things, as relates to construction, in any manner in the best interest of the partnership business with specific authority to make construction thereon and sell the same with or without any construction thereon or otherwise or to deal with it in any other manner.
6. That, all the Partners, i.e. Party of the First Part, Party of the Second Part and Party of the Third Part shall contribute the capital required for the partnership business as and when required and the same shall always be kept credited to their respective Capital accounts.
7. That all the Parties hereto shall be entitled to withdraw such sum of money as may be required by them from time from their respective Capital accounts and the amount so withdrawn shall be debited to their Capital accounts.
8. That the accounting year of the partnership firm shall be the financial year ending on the 31st day of March every year.
9. That the books of accounts of the partnership firm shall be kept in the principal place of business and the Partners shall have the right to access to and inspect and copy of the books of the firm, preferably during the business hours.

The Partners and the Partnership Firm shall ratify and be liable for any deeds of such person done legally within the frame of such authorization, appointment, deputation laid down in the instrument.

13. That, if required, the Firm, through the persons authorized in clause 11 and/or clause 12 above or otherwise, may borrow money from any persons, whether Banks, Financial Institutions, or otherwise, on loans at reasonable rate of interest and or other terms, with the consent of all the Partners in writing, whether by pledge of such securities or otherwise as agreed upon by them and other persons for the business of the partnership firm.

14. That the Profit and, God forbid, the losses of the firm shall be divided or borne by the Partners in the following ratio:

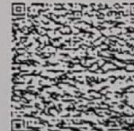

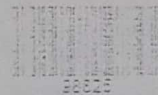
