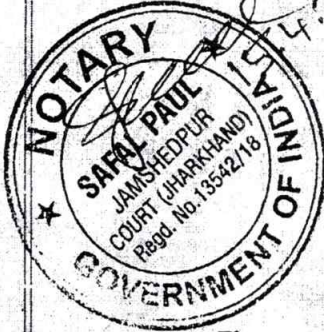

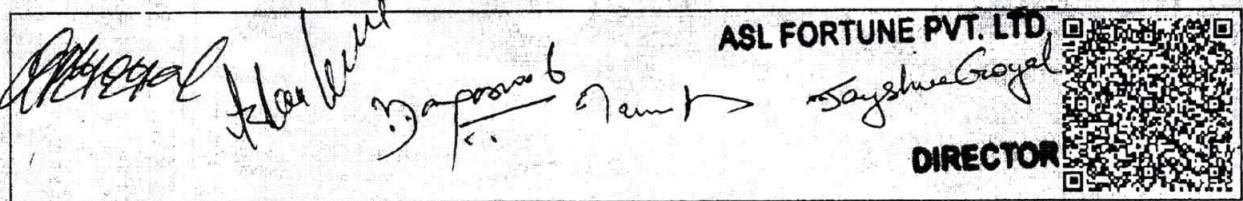

NOW IT IS HEREBY AGREED by and among the Designated Partners and body corporate partner to reduce in writing the changes made in the original LLP Agreement, which as under:

1. This Agreement is 1st Supplemental to the Initial Limited Liability Partnership Agreement of the LLP.
2. M/s. ASL Fortune Private Limited, represented by its Director Jayshree Goyal appointed as a body corporate partner of the LLP effective from 1st April, 2023.
3. The body corporate partner shall be entitled only to get interest on the contribution/loan given to the LLP subject to the provision of the Income Tax Act 1961, or any other applicable Laws for the being in force. The designated partners shall be at liberty to increase or reduce the rate of interest from time to time as per mutually decided terms and conditions.
4. The monetary value of capital of the LLP is remain same of Rs. 20,00,000/- (Rupees Twenty Lakh only) nevertheless the same shall be restructured in following proportion.

5. That the balance capital of Rs. 4,00,000/- from Dilip Kumar Goyal and Rs. 4,00,000 from Navin Agarwal has been transfer to them and ASL Fortunes Private Limited has introduced Rs. 8,00,000 as a capital into LLP.
6. The net profit/loss of the LLP arrived at after providing for payment of remuneration to the designated partners and interest to the body corporate partner on the capital/loan given by them shall be divided in the following proportions:






