3 (a) The objects to be pursued by the company on its incorporation are

1 To carry on the business of, civil engineers, surveyors, designers, town planners, estimators, valuers interior and exterior decorators, general and Government civil contractors of immovable properties including building, residential and commercial complexes, highways, roads, earth ways, bridges, dams, tunnels, waterways, sea ports in general and under port BOT system and all types of structural and joining engineering work, interior designing and graphics.

2 To construct, erect, build, repair, or rebuild, demolish, develop, improve, grade, curve, pave, macadamize, cement and maintain building structures, houses, apartments, hospitals, schools, places of worship, highways, roads, path, streets, sideways, courts, alleys, passages and to do other similar constructions, levelling or paving works, and for these purposes to purchase, take on lease, or otherwise acquire and hold any lands and prepare lay out thereon or buildings of any tenure or description wherever situate, rights or interests therein or connected therewith.

4 (b) Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1 To enter into any arrangement with any Government or authority, central, provincial, municipal, local or otherwise, or quasi public body, that may seem conducive to the Company's objects or any of them, and to obtain from any such Government or Authority any right, privilege and concession which the Company may think it desirable to obtain & carry out, exercise and comply with any such arrangement, right, privilege & concession.

(i) The provisions of Articles (2) and (3) shall mutatis mutandis apply to debentures of the company.

Except as required by law, no person shall be recognised by the company as holding any share upon any trust, and the company shall not be bound by, or be compelled in any way to recognise (even when having notice thereof) any equitable, contingent, future or partial interest in any share, or any interest in any fractional part of a share, or (except only as by these regulations or by law otherwise provided) any other rights in respect of any share except an absolute right to the entirety thereof in the registered holder.

(iii) The commission may be satisfied by the payment of cash or the allotment of fully or partly paid shares or partly in the one way and partly in the other.

(i) If at any time the share capital is divided into different classes of shares, the rights attached to any class (unless otherwise provided by the terms of issue of the shares of that class) may, subject to the provisions of section 48, and whether or not the company is being wound up, be varied with the consent in writing of the holders of three-fourths of the issued shares of that class, or with the sanction of a special resolution passed at a separate meeting of the holders of the shares of that class.

(ii) To every such separate meeting, the provisions of these regulations relating to general meetings shall mutatis mutandis apply, but so that the necessary quorum shall be at least two persons holding at least one-third of the issued shares of the class in question.

The rights conferred upon the holders of the shares of any class issued with preferred or other rights shall not, unless otherwise expressly provided by the terms of issue of the shares of that class, be deemed to be varied by the creation or issue of further shares ranking pari passu therewith.

**Lien**

(i) The company shall have a first and paramount lien-  
(a) on every share (not being a fully paid share), for all monies (whether presently payable or not) called, or payable at a fixed time, in respect of that share; and  
(b) on all shares (not being fully paid shares) standing registered in the name of a single person, for all monies presently payable by him or his estate to the company.

Provided that the Board of directors may at any time declare any share to be wholly or in part exempt from the provisions of this clause.

(ii) The company's lien, if any, on a share shall extend to all dividends payable and bonuses declared from time to time in respect of such shares.

The company may sell, in such manner as the Board thinks fit, any shares on which the company has a lien. Provided that no sale shall be made-

(a) unless a sum in respect of which the lien exists is presently payable; or  
(b) until the expiration of fourteen days after a notice in writing stating and demanding payment of such part of the amount in respect of which the lien exists as is presently payable, has been given to the registered holder for the time being of the share or the person entitled thereto by reason of his death or insolvency.

(i) To give effect to any such sale, the Board may authorise some person to transfer the shares sold to the purchaser thereof.

(ii) The purchaser shall be registered as the holder of the shares comprised in any such transfer.

(iii) The purchaser shall not be bound to see to the application of the purchase money, nor shall his title to the shares be affected by any irregularity or invalidity in the proceedings in reference to the sale.

(i) The proceeds of the sale shall be received by the company and applied in payment of such part of the amount in respect of which the lien exists as is presently payable.

(ii) The residue, if any, shall, subject to a like lien for sums not presently payable as existed upon the shares before the sale, be paid to the person entitled to the shares at the date of the sale.

**Calls on shares**

(ii) Each member shall, subject to receiving at least fourteen days' notice specifying the time or times and place of payment, pay to the company, at the time or times and place so specified, the amount called on his shares.
