Whereas, the said downer is the absolutes owner in possession of land, tenements and premises situated at Village- JHTREE., Distrist-Ranchi begging R.S/M.S Plot no.- ... 8.2-3..., Sub plotNo.- ...., Khata No.- .0.3...., Thana No.- ... 4.5..... (Detailed of Land).


