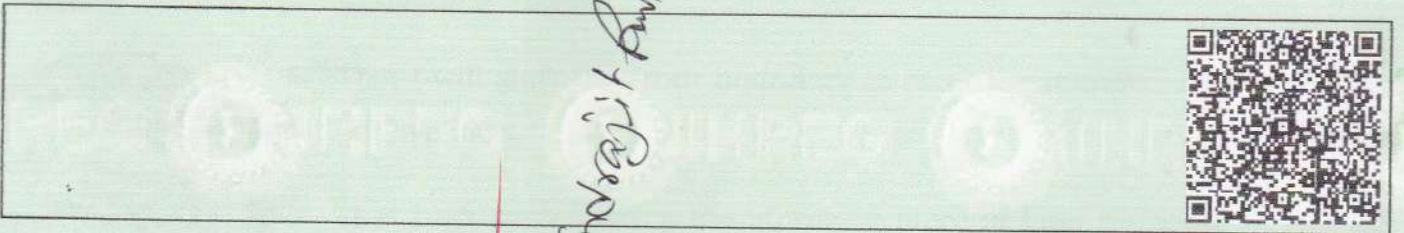




1. That I am Indian citizen since by birth


