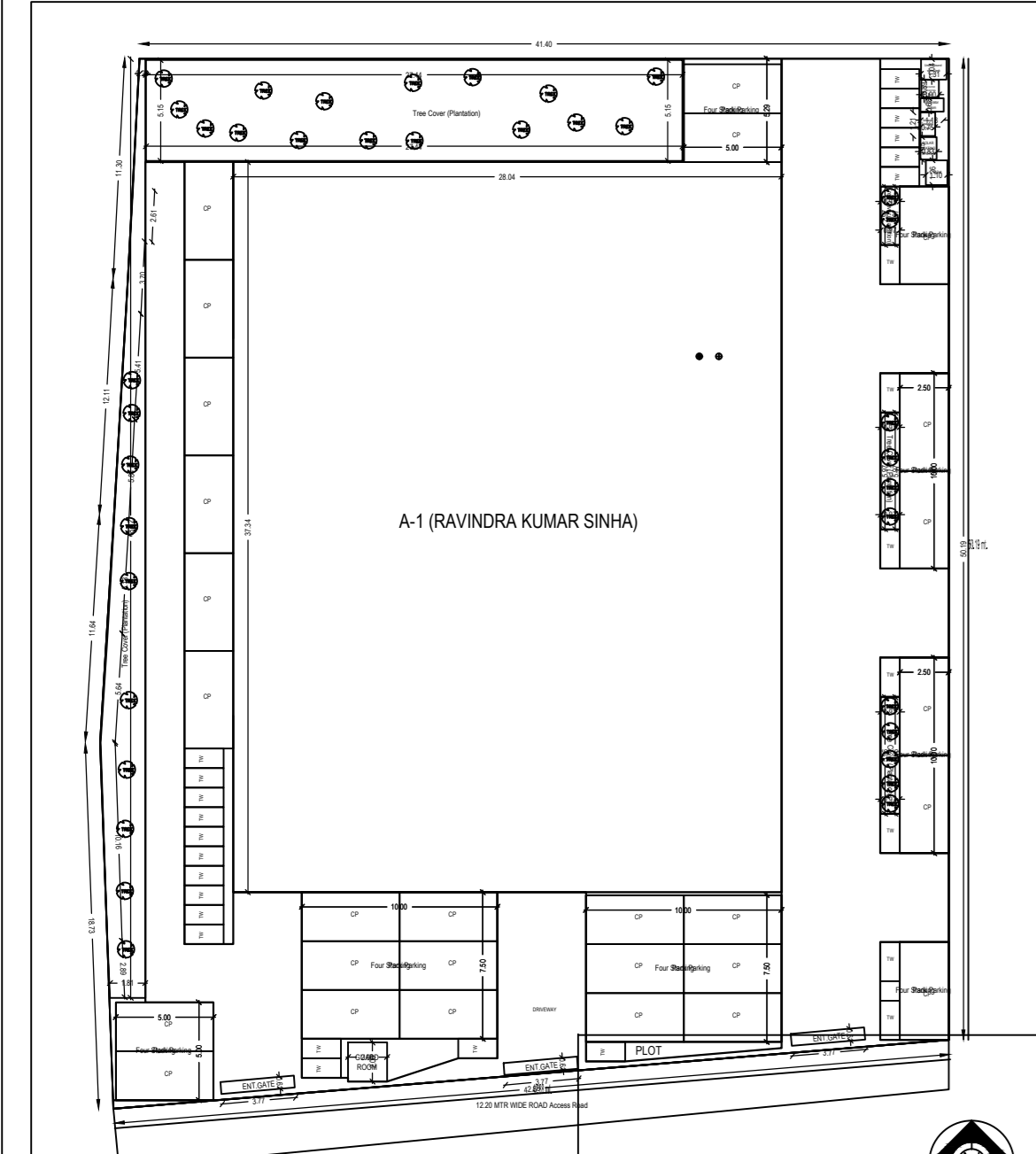


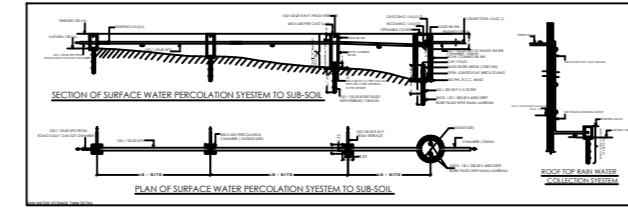

GROUND FLOOR PLAN SCALE:1:100

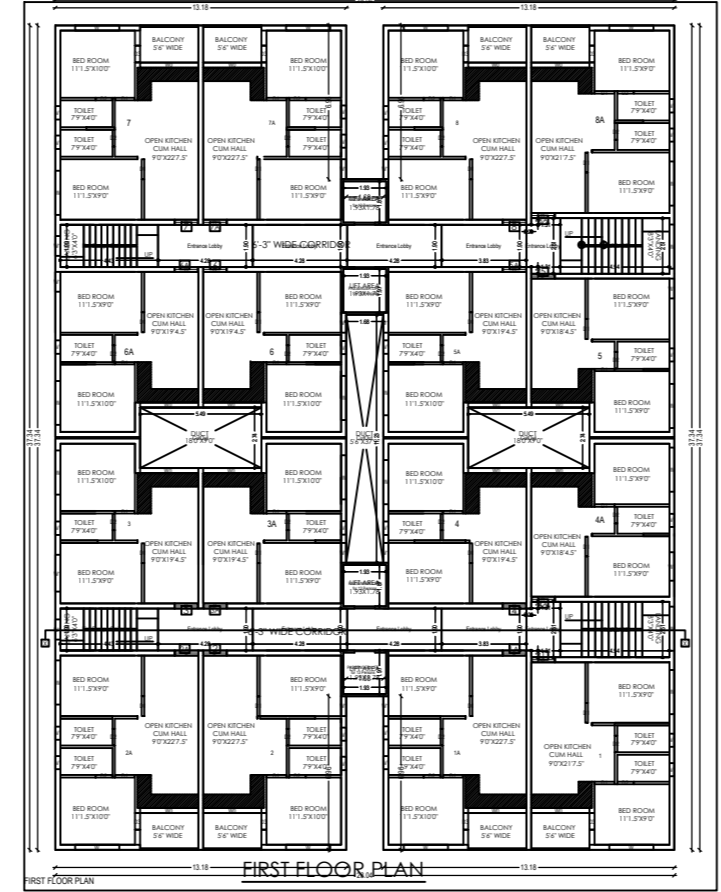
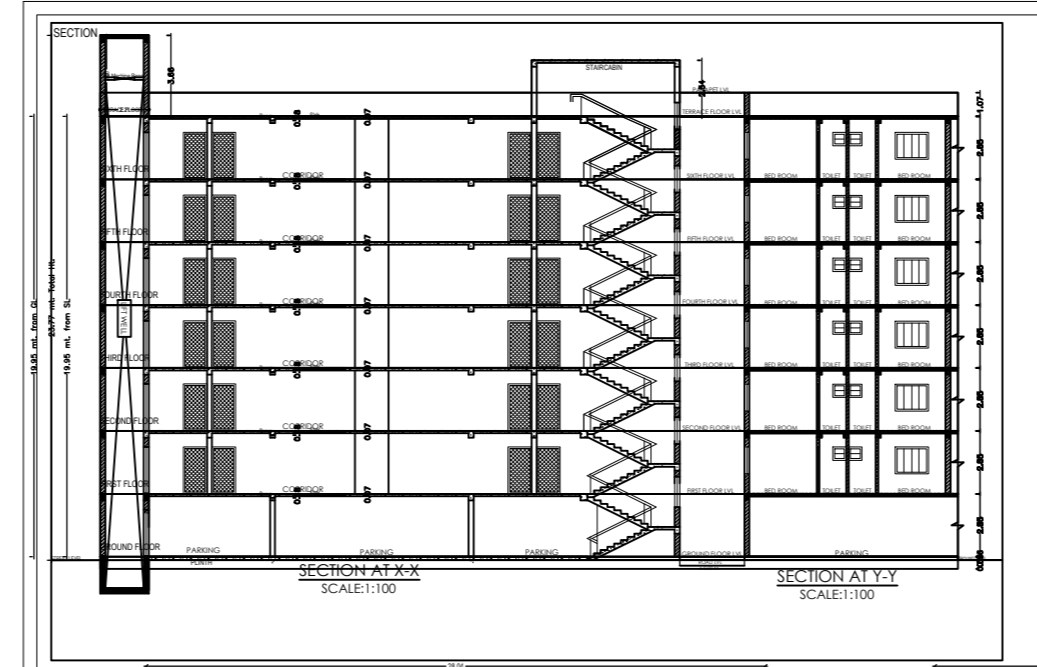

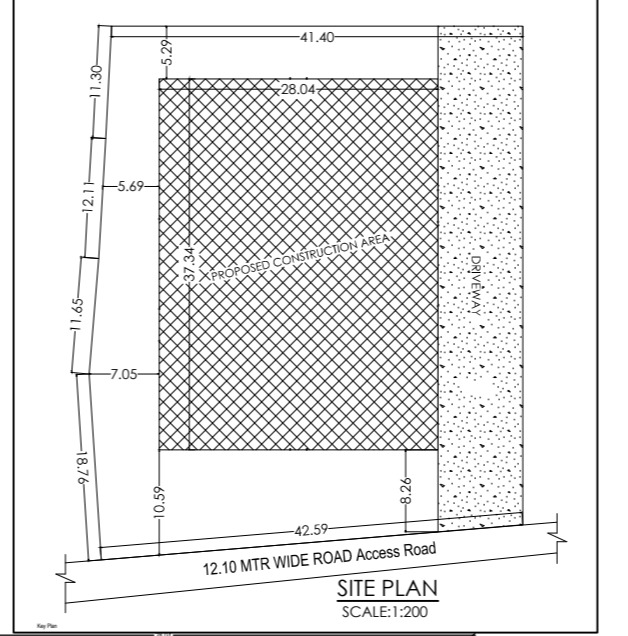

SECOND TO FIFTH FLOOR PLAN

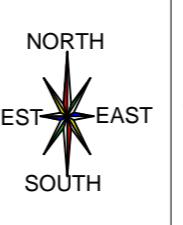

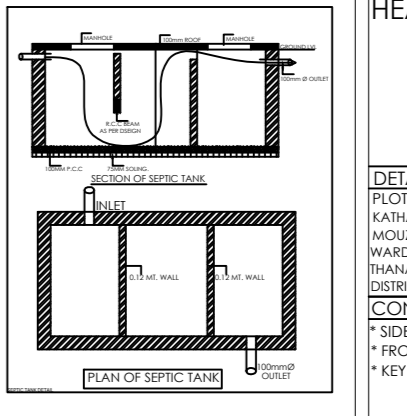
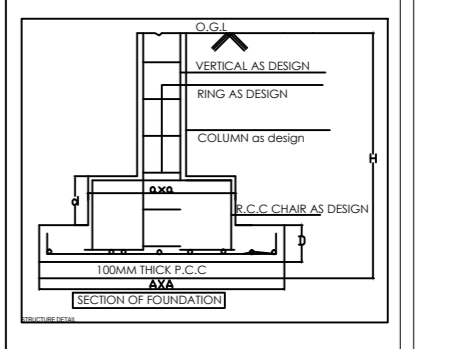
