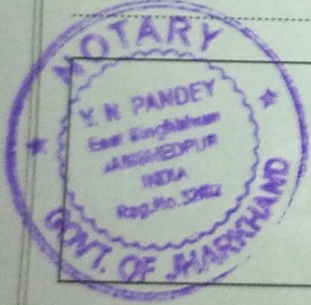

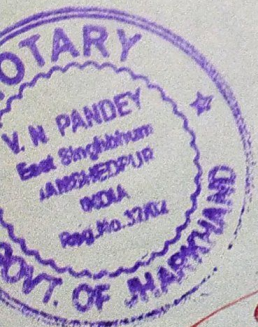

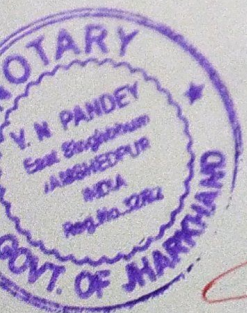

And whereas the executant has agreed to execute an indemnity bond to the above affect and also to abide by the terms imposed by the concerned..... Authority the grant of sanction for construction of the basement.

Now the deed witnesses:

1. That in consideration of the sanction of the plans by Authority for construction of the basement the executant undertakes that he / she shall at all times keep..... Authority free from any liability, loss or damages/ flowing from any injury or damage caused to the adjoining built up properties or to any person as a consequence of the construction of at the time of its foundations or during the course of its construction or at any time thereafter.
2. The owner agreed and undertakes that in the event of any claim being made by any person against the concerned authority either in respect of the sanction granted by the concerned authority to the owner for the construction of basement or in respect of the construction of manner of construction of the basement by the owner of the consequences flowing from the said sanction the executant shall be responsible and liable and not Authority.
3. The executant agrees and undertake to indemnify the concerned authority fully in respect of any amount which the concerned authority may be required to pay to any person either by way of compensation or on any other account as a result of any claim or suit or any other proceedings concerning the sanctioning of the construction of the basement of the making there of and also in respect of the costs and expenses

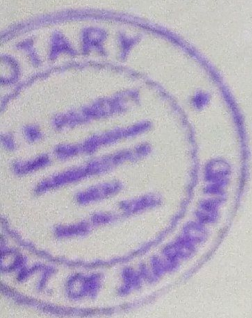
