That in consideration of the sanction of the plans by Adityapur Municipal Corporation Authority for construction of the basement the executant undertakes that he/she shall at all times keep Adityapur Municipal Corporation Authority free from liability, loss or damages/ flowing from any injury or damage caused to the adjoining built up properties or to any person as a consequence of the construction of at the time of digging of its foundations or during the course of its construction or at any time thereafter.

The owner agreed and undertakes that in the event of any claim being made by any person or persons against the concerned Authority either in respect of the sanction granted by the concerned Authority to the owner for the construction of basement or in respect of the construction or manner of construction of the basement by the owner of the consequences flowing from the said sanction the executant shall be responsible and liable and not Adityapur Municipal Corporation Authority.
