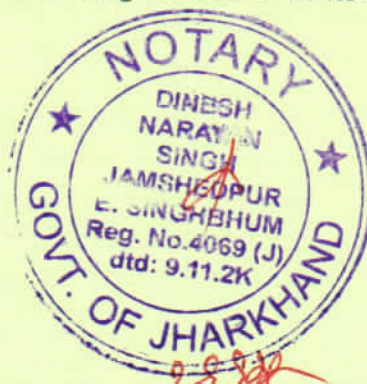




Now the deed witnesses:

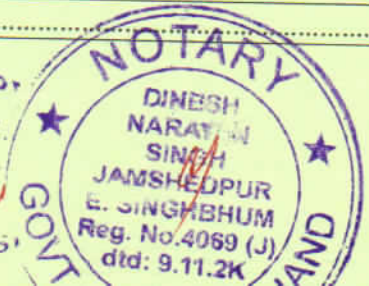

2. The owner agreed and undertakes that in the event of any claim being made by any person or persons against the concerned Authority either in respect of the sanction granted by the concerned Authority to the owner for the construction of basement or in respect of the construction or manner of the construction of the basement by the owner of the consequences flowing from the said sanction the executant shall be responsible and liable and not AMC Authority.
3. The executant agrees and undertake to indemnify the concerned Authority fully in respect of any amount which the concerned Authority may be required to pay to any persons either by way of compensation or on any other account as a result of any claim or suit or any other proceedings concerning the sanctioning of the construction of the basement of the making there of and also in respect of the costs and expenses which the concerned Authority may incur on defending any actions.
4. Without prejudice to the above undertaking the executant hereby binds itself to pay to AMC Authority to the full extent any amount which AMC Authority may be required to pay to any person in connection with relating to or concerning the sanctioning or the basement of the making thereof.
