

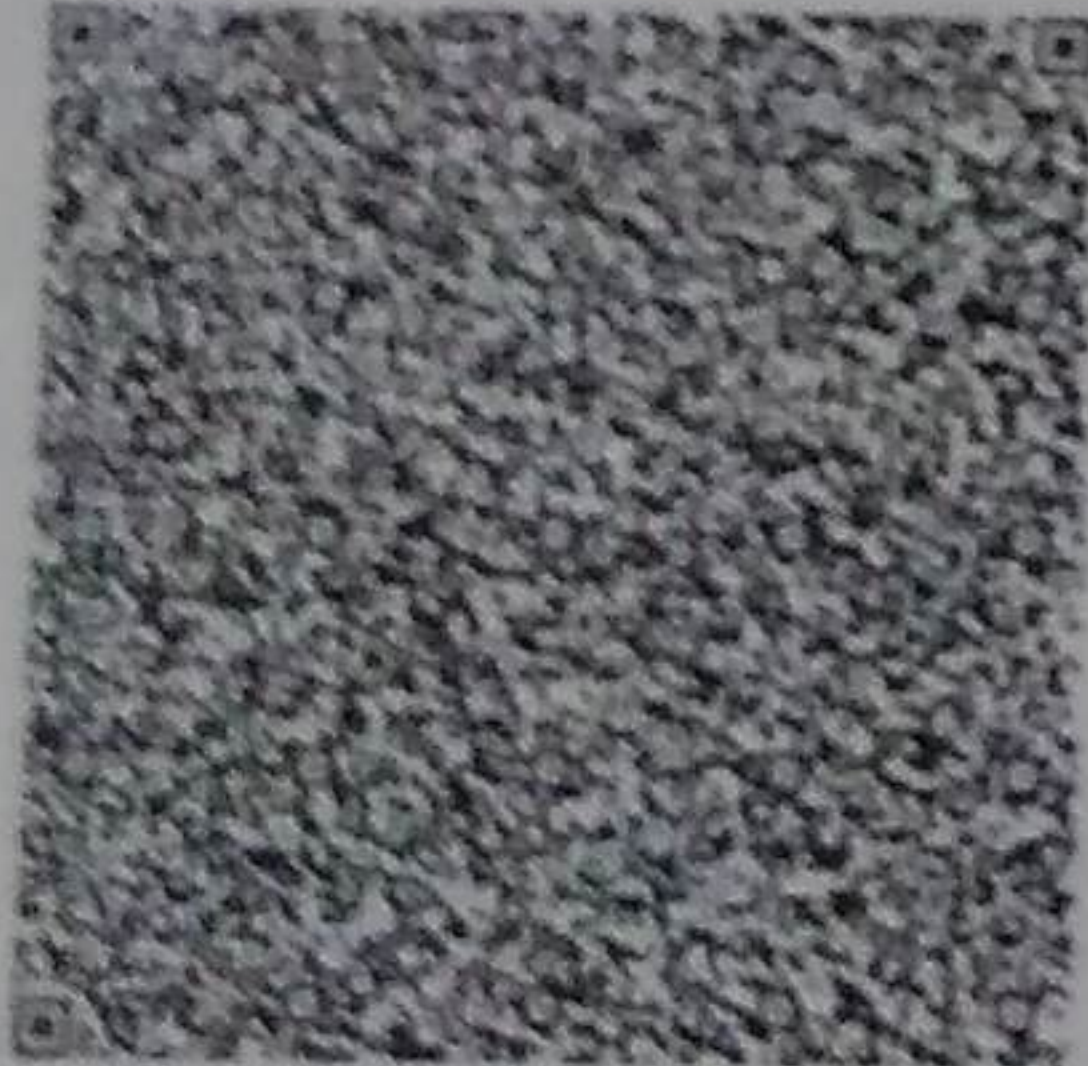

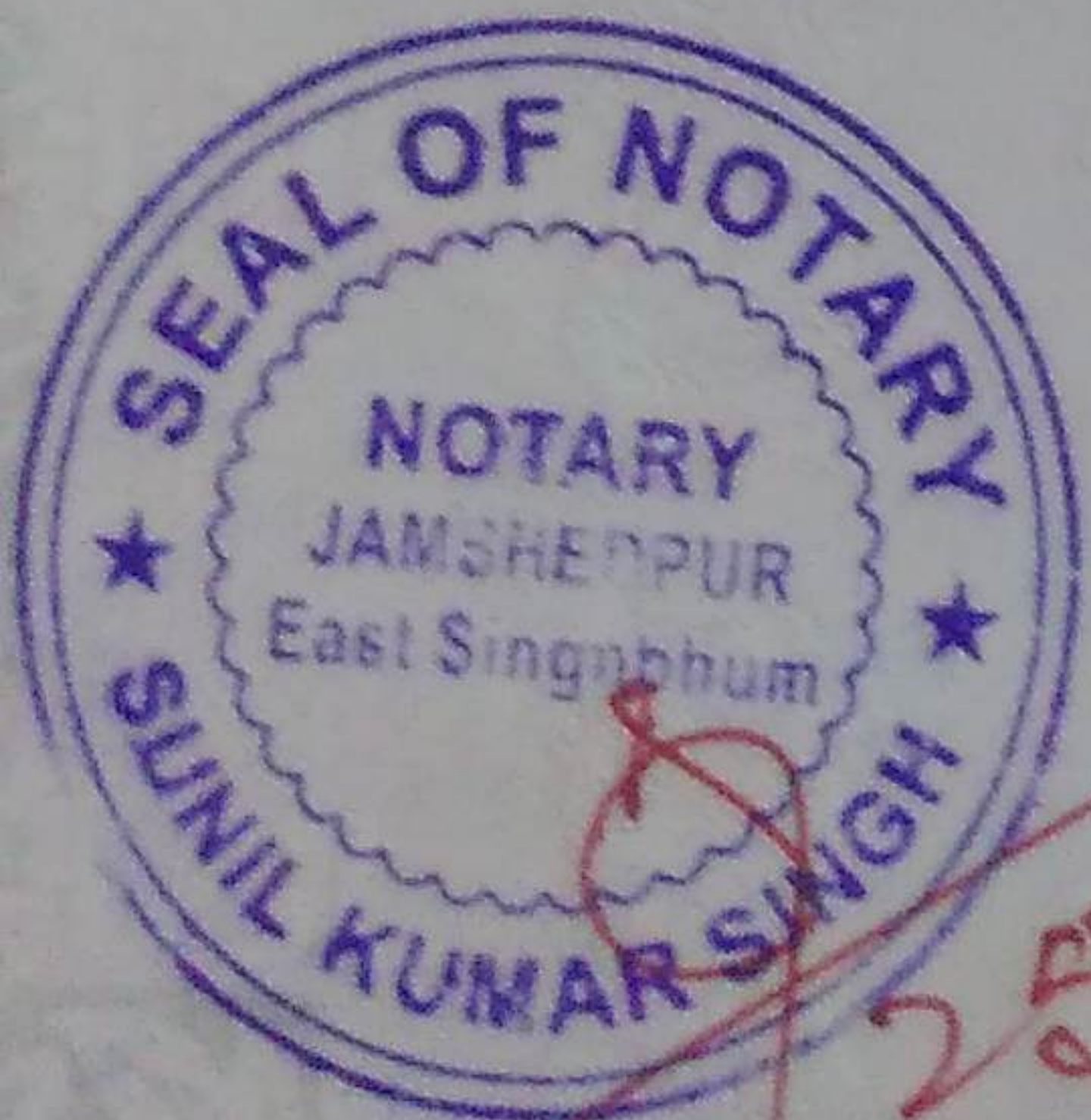

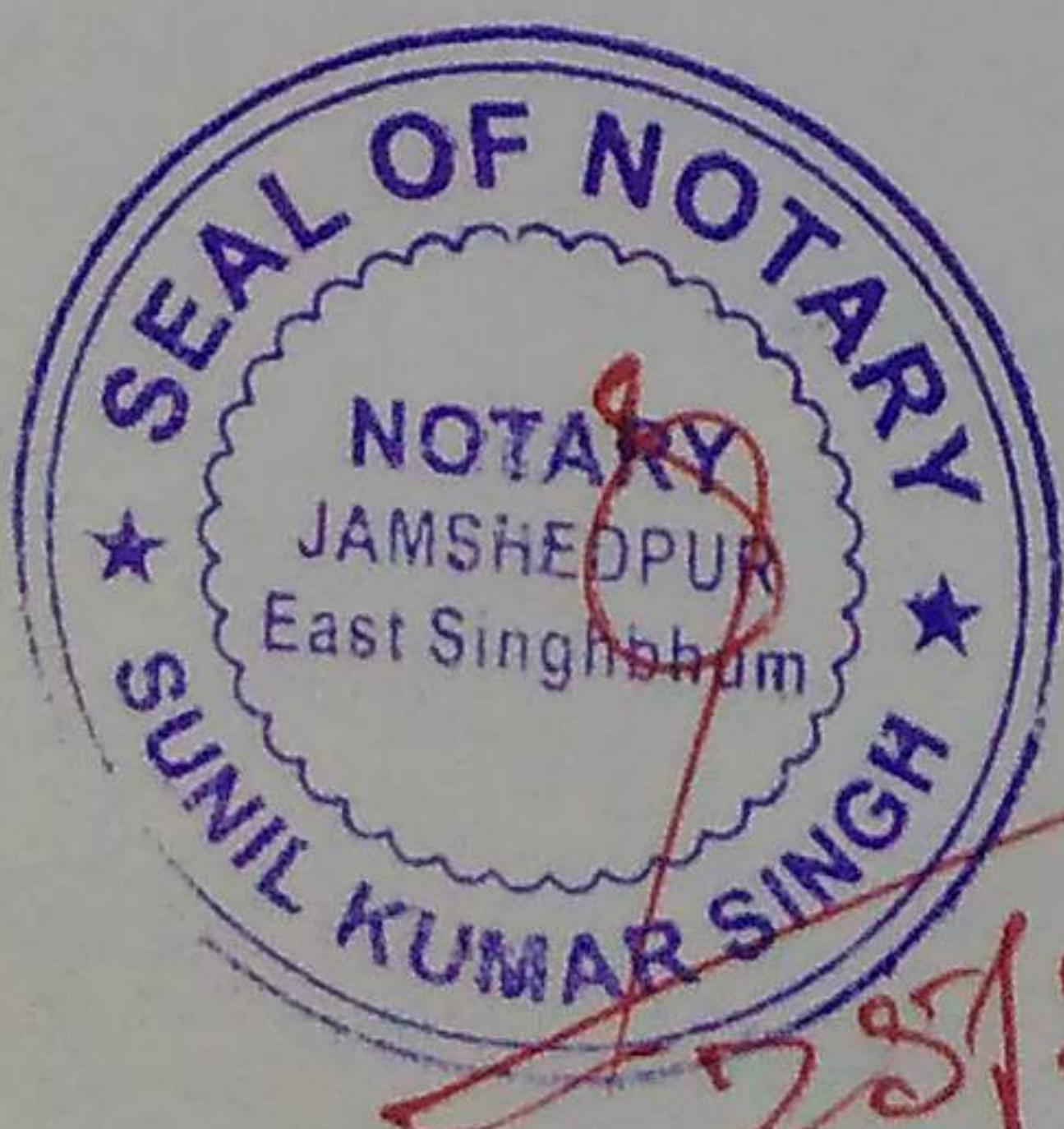
**AFFIDAVIT**
