1. You will pay all the dues in respect of the holding and shall submit a photocopy of the latest payment receipt.
2. You are hereby directed to deposit a sum of Rs.140/- (Rupees one hundred forty) only by a pay order drawn in favour of "Tata Steel Limited" and deposit in Land Office towards administrative charges and expenses.
3. You shall pay a penalty, as fixed by the Government, calculated @ Rs.4.50 lakhs per acre, which comes to Rs.12,397/- (Rupees twelve thousand three hundred ninety seven) only by a separate pay order drawn in favour of "Tata Steel Limited" and deposit in Land Office. You shall be liable to pay any further demand together with any interest, raised by the appropriate authorities or the State Government, in connection with the penalty for executing the transfer deed without the permission/approval.
4. You shall submit an Indemnity Bond, indemnifying the Steel Company against any claim that may be preferred in respect of the holding by anyone else in future, arising from the change of records in your name (Draft Format enclosed).
5. The conversion of the monthly tenancy holding into sub-lease has been granted vide our letter No.LAND/CONV/3045, dated 02.11.2009.
