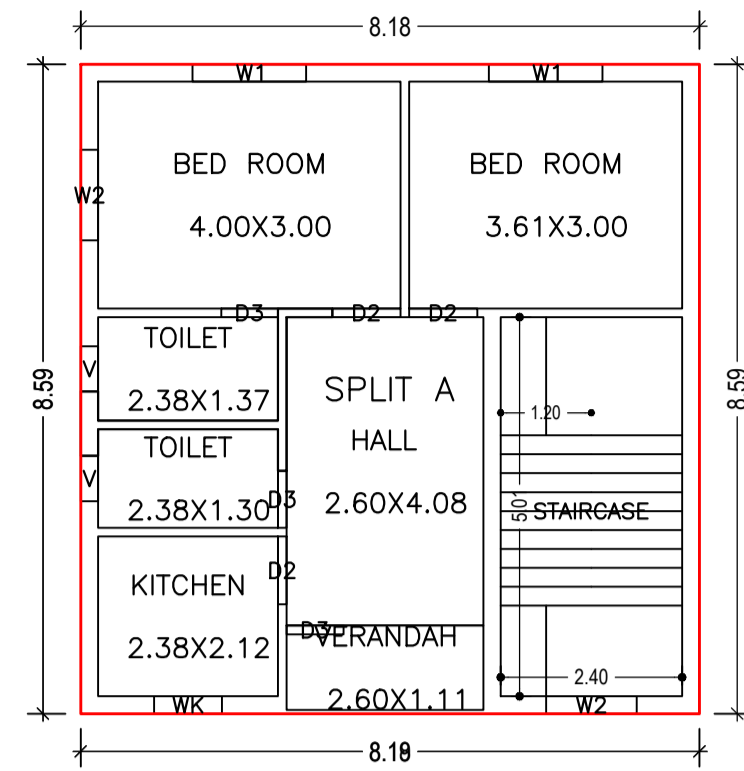

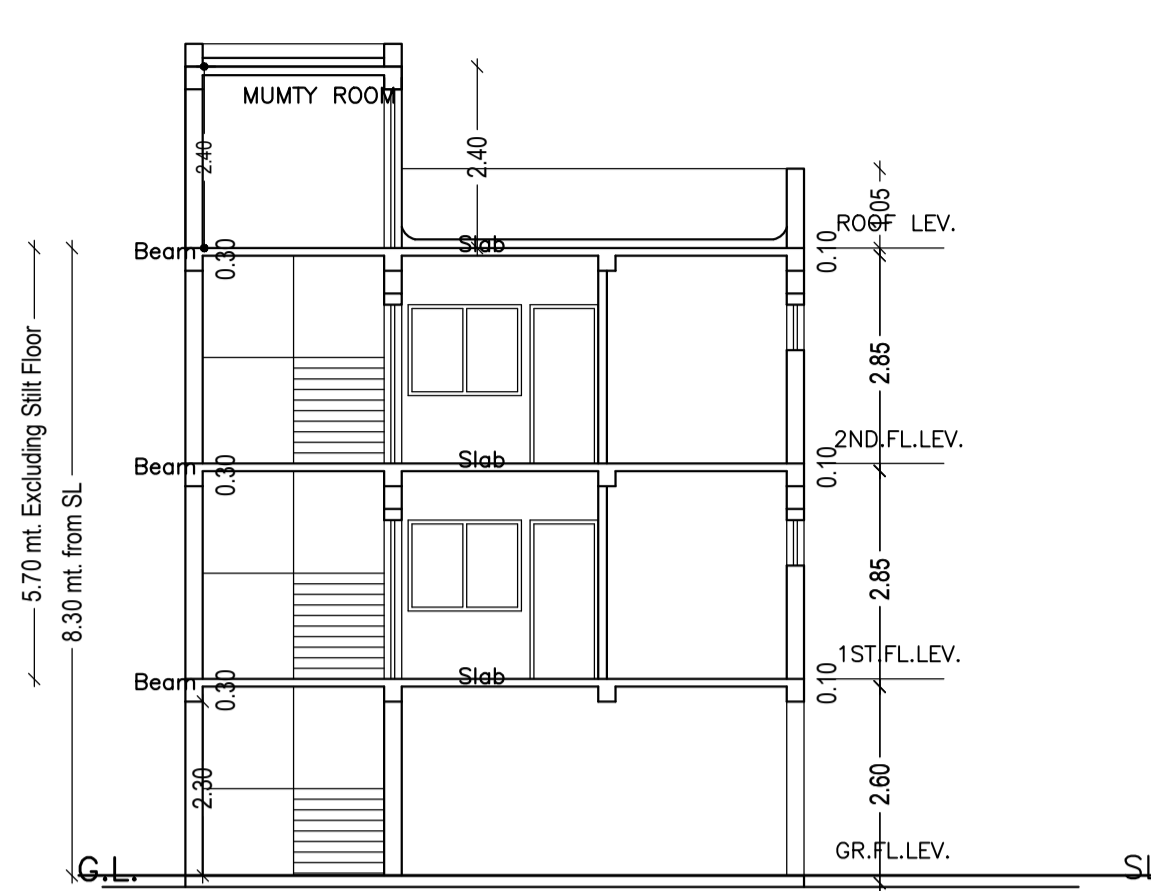

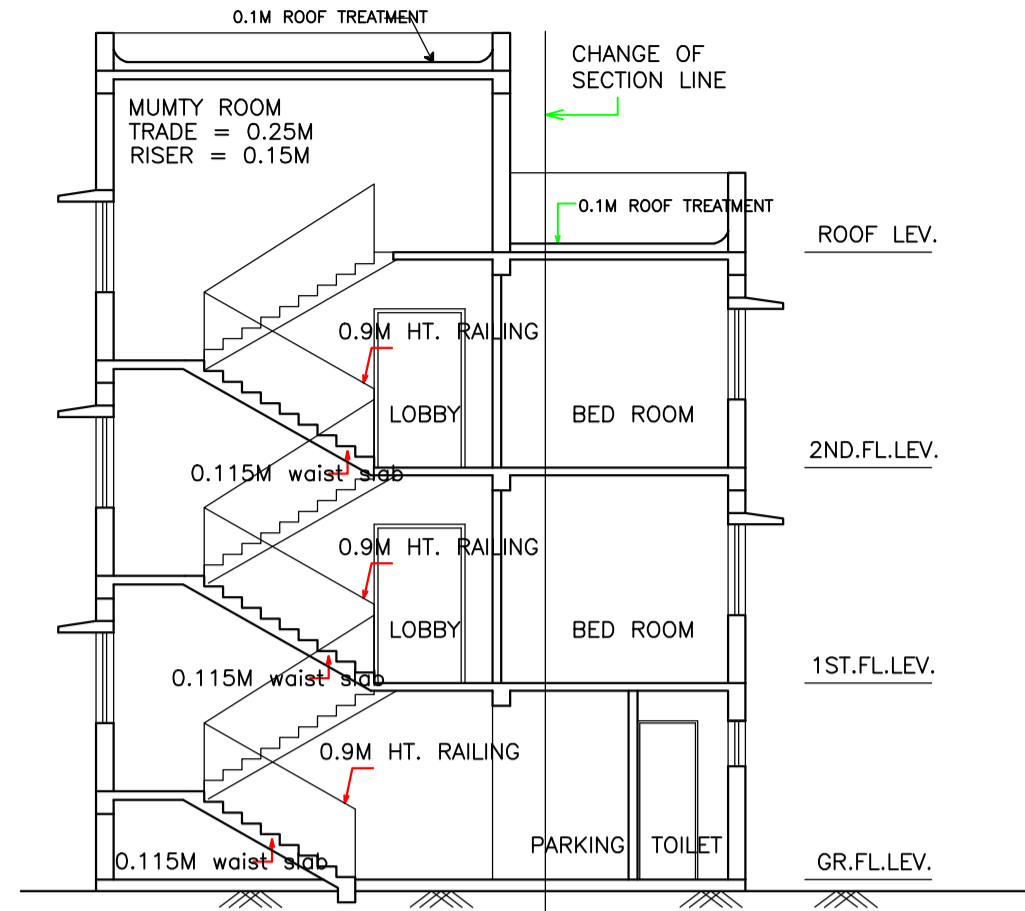

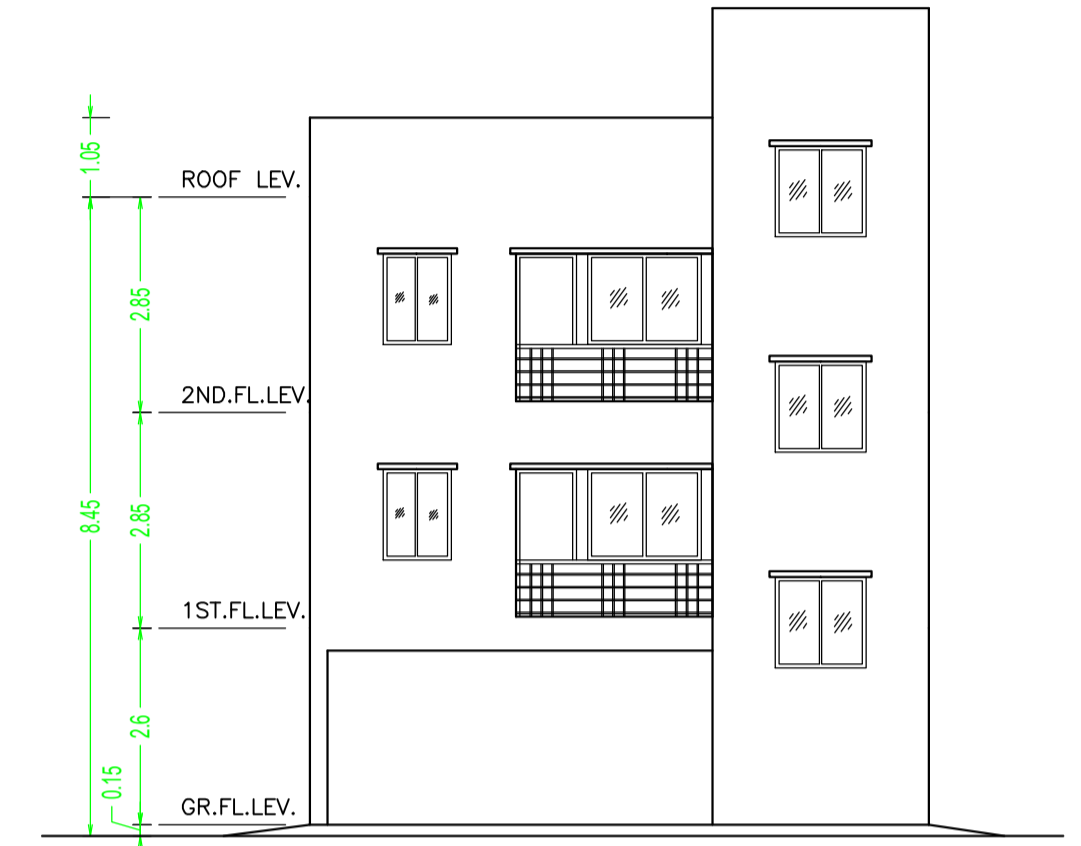
SECOND FLOOR PLAN (Proposed) (SCALE 1:100)

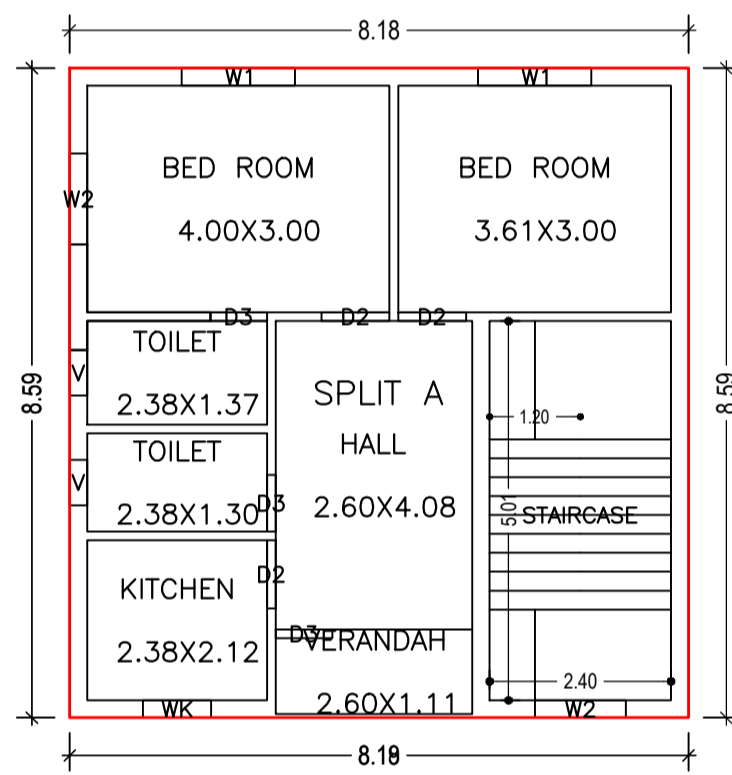


SECTION - Y-Y (SCALE 1:100)

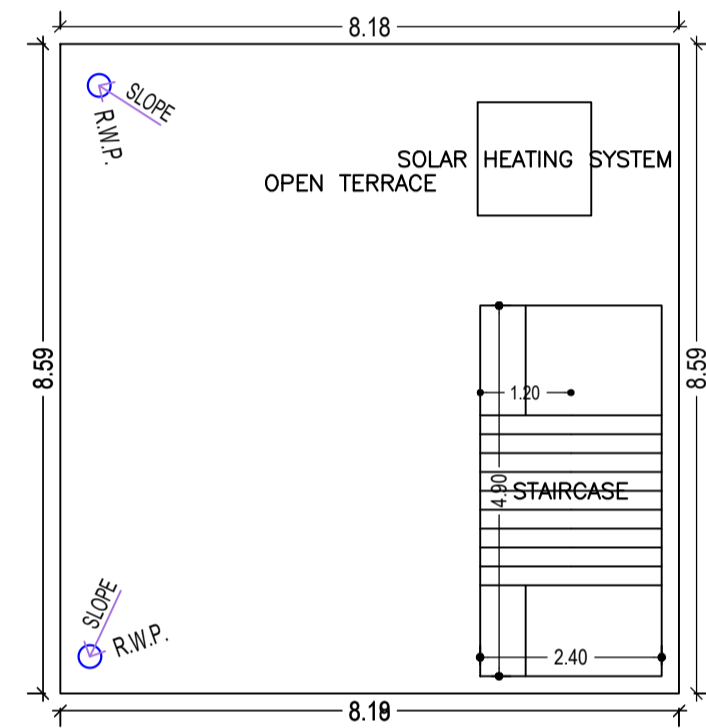


FRONT ELEVATION (SCALE 1:100)

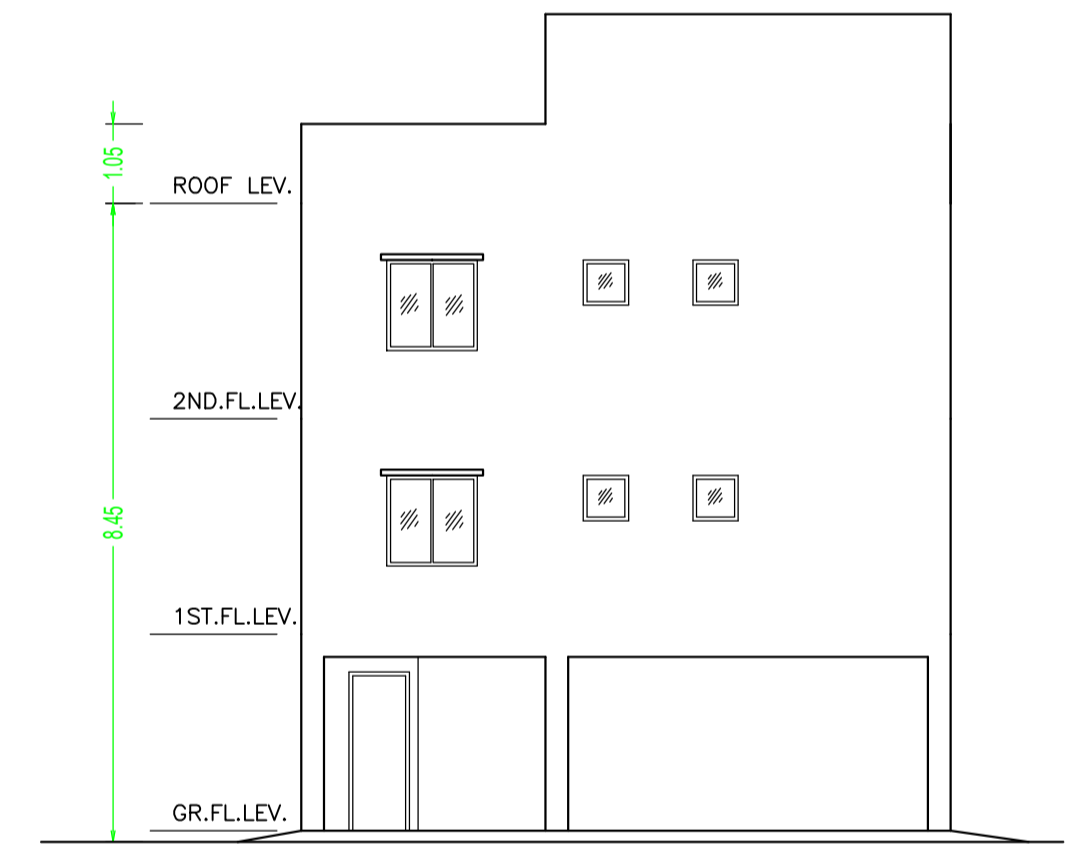
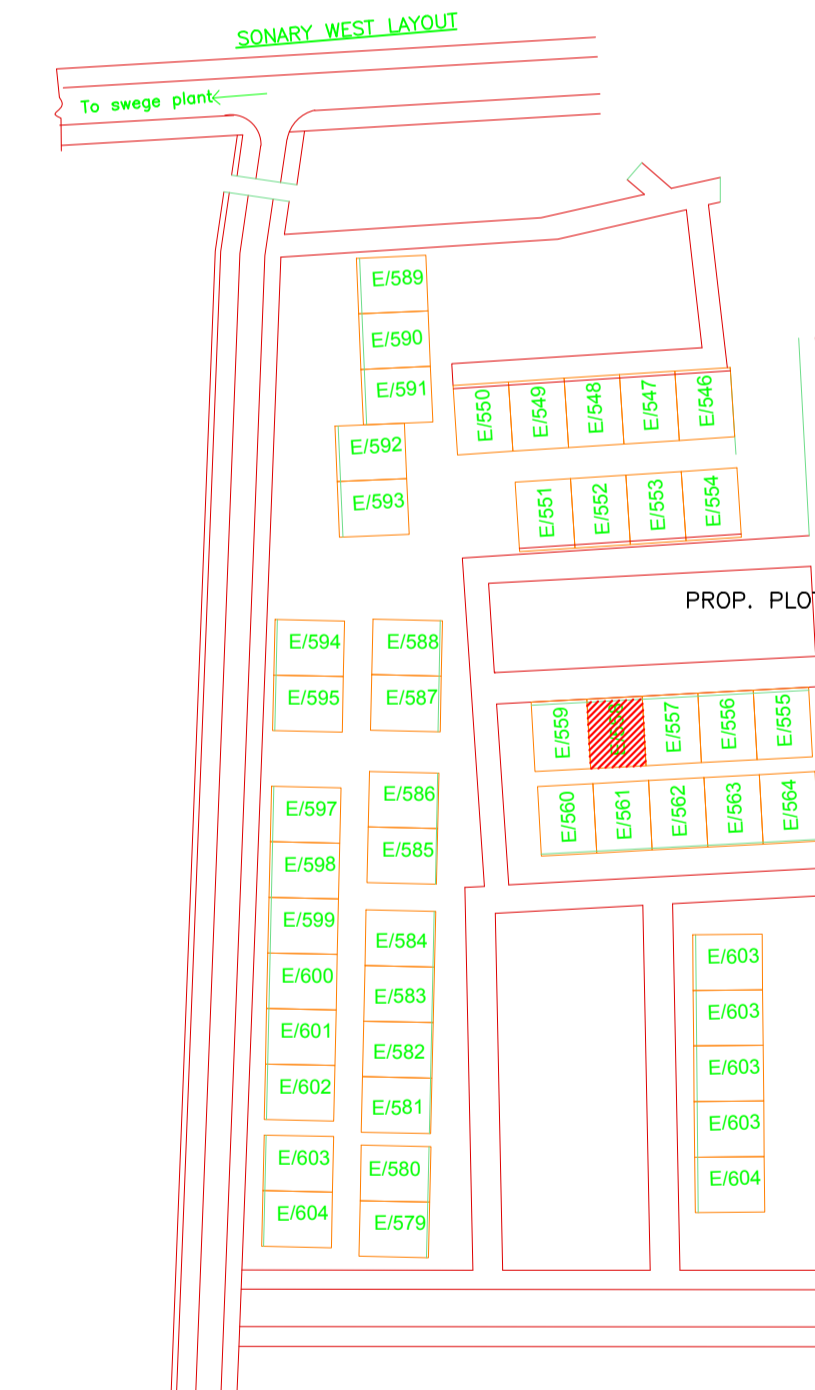
PARKING FLOOR PLAN (SCALE 1:100)



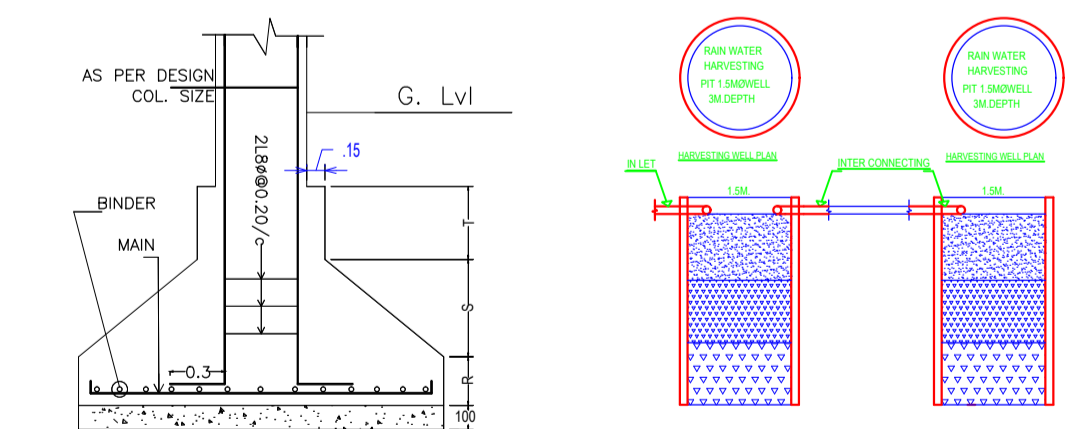
FIRST FLOOR PLAN (Proposed) (SCALE 1:100)
