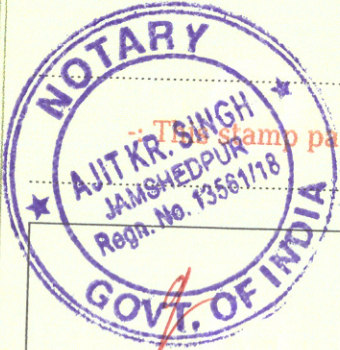

4. That I/We under take that any circumstances no deviation will be done in construction/development process as well as occupancy proposed in sanctioned plan.

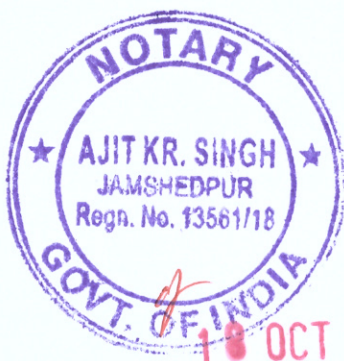
5. If I/We fail to comply with the aforementioned conditions fully or partially JNAC may cancel my registration/License and may take law-full action against me.
