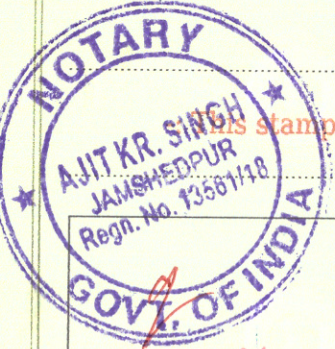


APPLICANT'S/BUILDER'S AFFIDAVIT

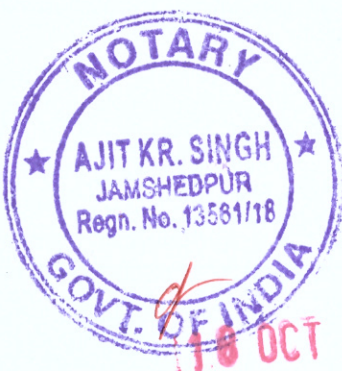


