**Regularisation of unauthorised transfer and mutation of names-

Holding No.9, Circuit House (North-East) Area, measuring 0.350 acre or 109' x 140' stands sub-leased in the joint names of (1) Smt. Ipshita Chakladar, (2) Smt. Sima Agarwal, (3) Sri Adarsh Dodrajka and (4) Sri Anand Dodrajka, for residential purposes.

A portion of the Holding No. 9, Circuit House (North-East) Area, measuring 37' x 140' (out of 0.350 acre or 109' x 140'), has been sold vide registered Sale Deed No.3050/2729 dated 16.07.2016, executed by Smt. Ipshita Chakladar, the co-sub-lessee, through her Attorney Holder Sri Sanjay Chakladar, by virtue of Special Power of Attorney certified by the Secretary of the Commonwealth at Boston, Massachusetts, vide No.1842010 dated 14.09.2015, in favour of Smt. Sima Agarwal, Sri Adarsh Dodrajka and Sri Anand Dodrajka, for a sale value of Rs.1,80,00,000/- (Rupees one crore eighty lakhs) only.


