In this connection we would like to inform that the following pieces of land measuring 40.74 acres, in Circuit House Area (East), stands sub-leased in the name of the Trustees of Xavier Labour Relations Institute (XLRI) on the terms and conditions of Clubs and Association lease.

The photo copies of Possession Certificates/ Letters of Confirmation of the aforesaid pieces of land are enclosed.

Subsequently, all the four sub-leases from Srl. No. 01 to 04 above have been amalgamated into one single sub-lease over the total area measuring 29.050 acres for the period from 01.08.1977 to 31.12.1995 on a total ground rent of Rs. 16/- per annum was granted vide our letter No. TAL/VRM/7243 dated 09.12.1995 (copy enclosed). The said sub-leases have been renewed vide letter No. TAL/4543 dated 29.08.2000 (copy enclosed), for a further period of 30 years with effect from 01.01.1996 to 31.12.2025 at the enhanced rent of Rs. 32/- per annum and the Sub-lease Deed have not been executed and registered.

The new Sub-lease Deed in respect of land at Srl. No. 05 & 06 above has also not been executed and registered.

The sub-leases of the above land is still continuing in the name of the Trustees of Xavier Labour Relations Institute (XLRI).
