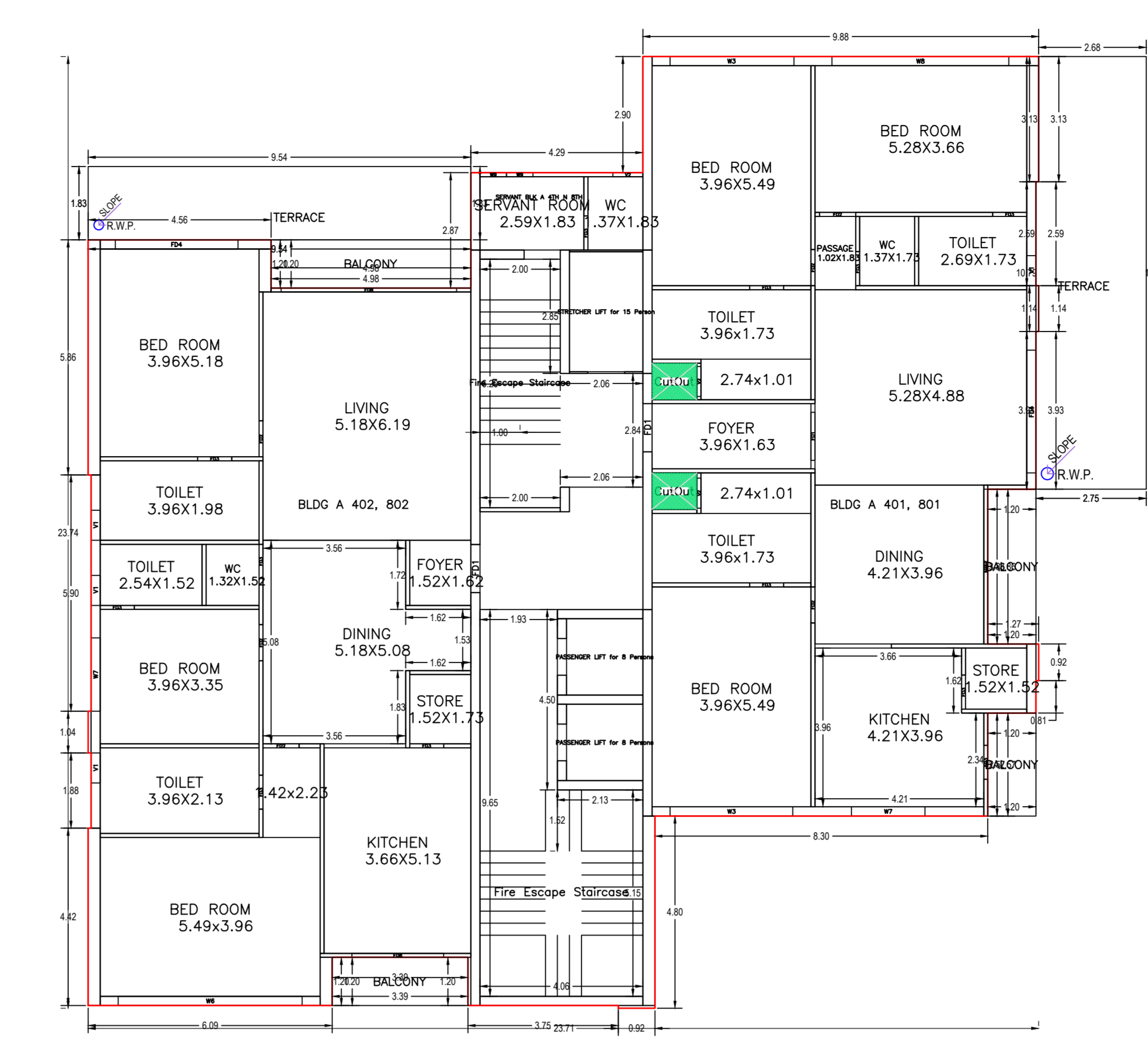
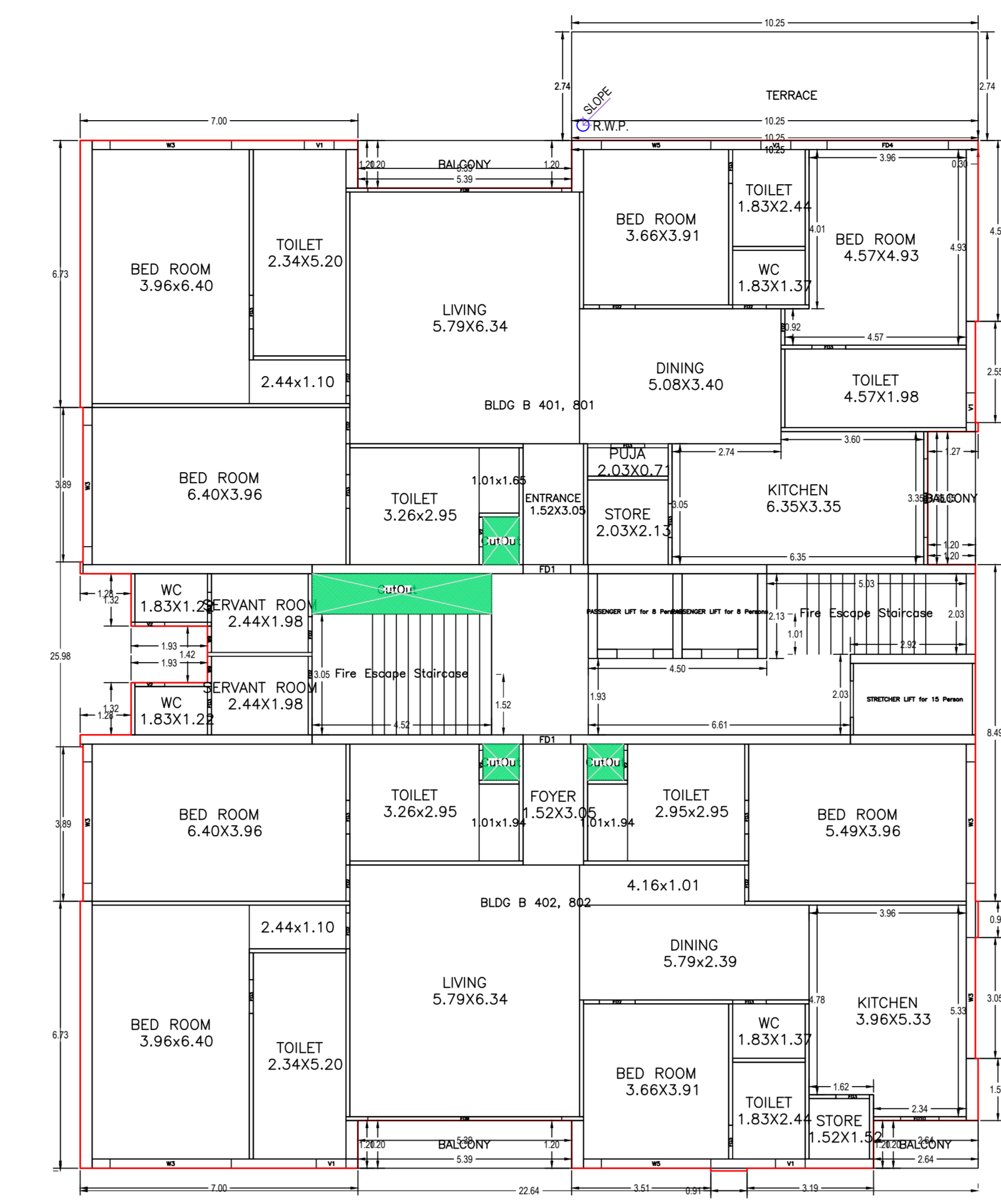
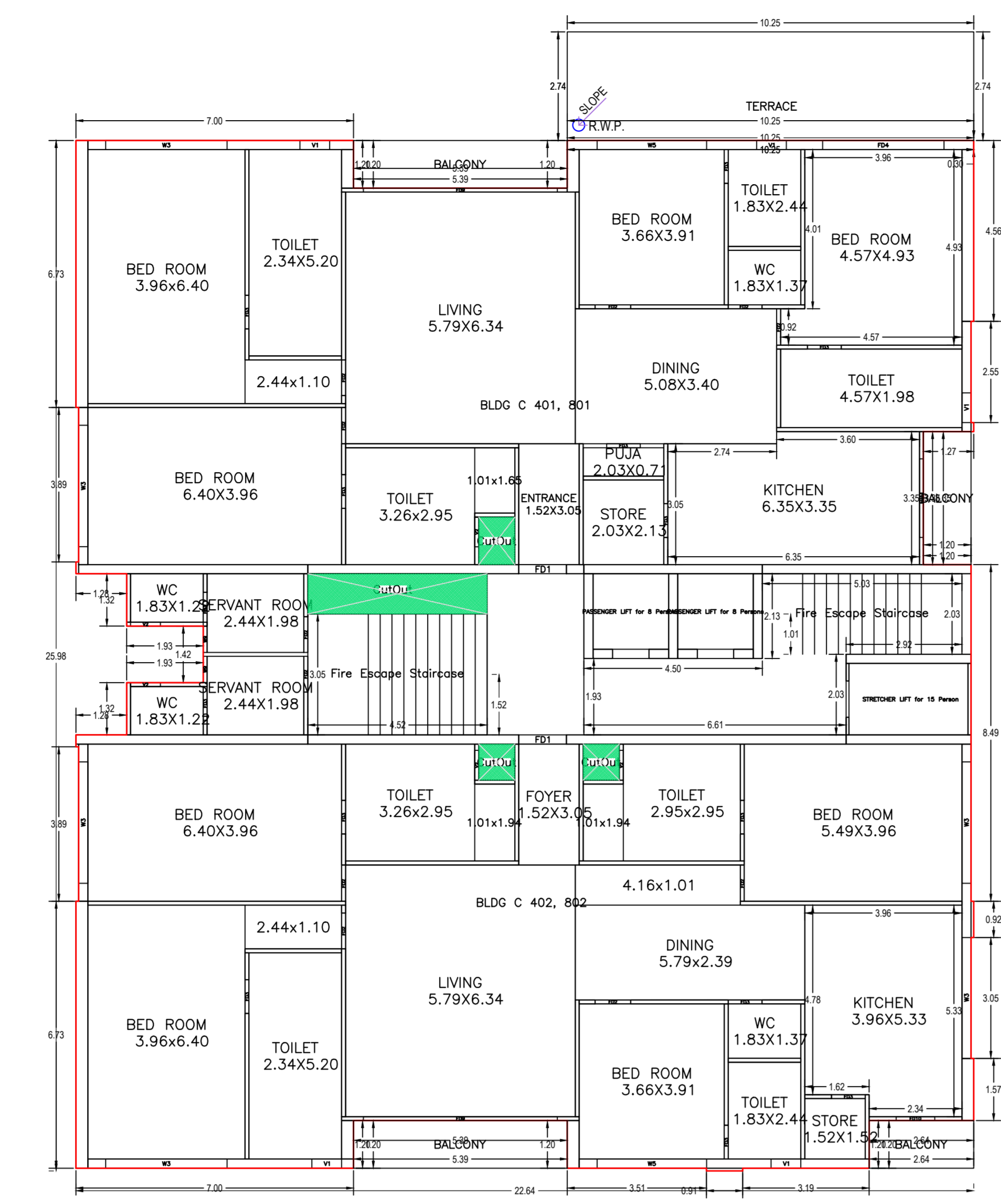
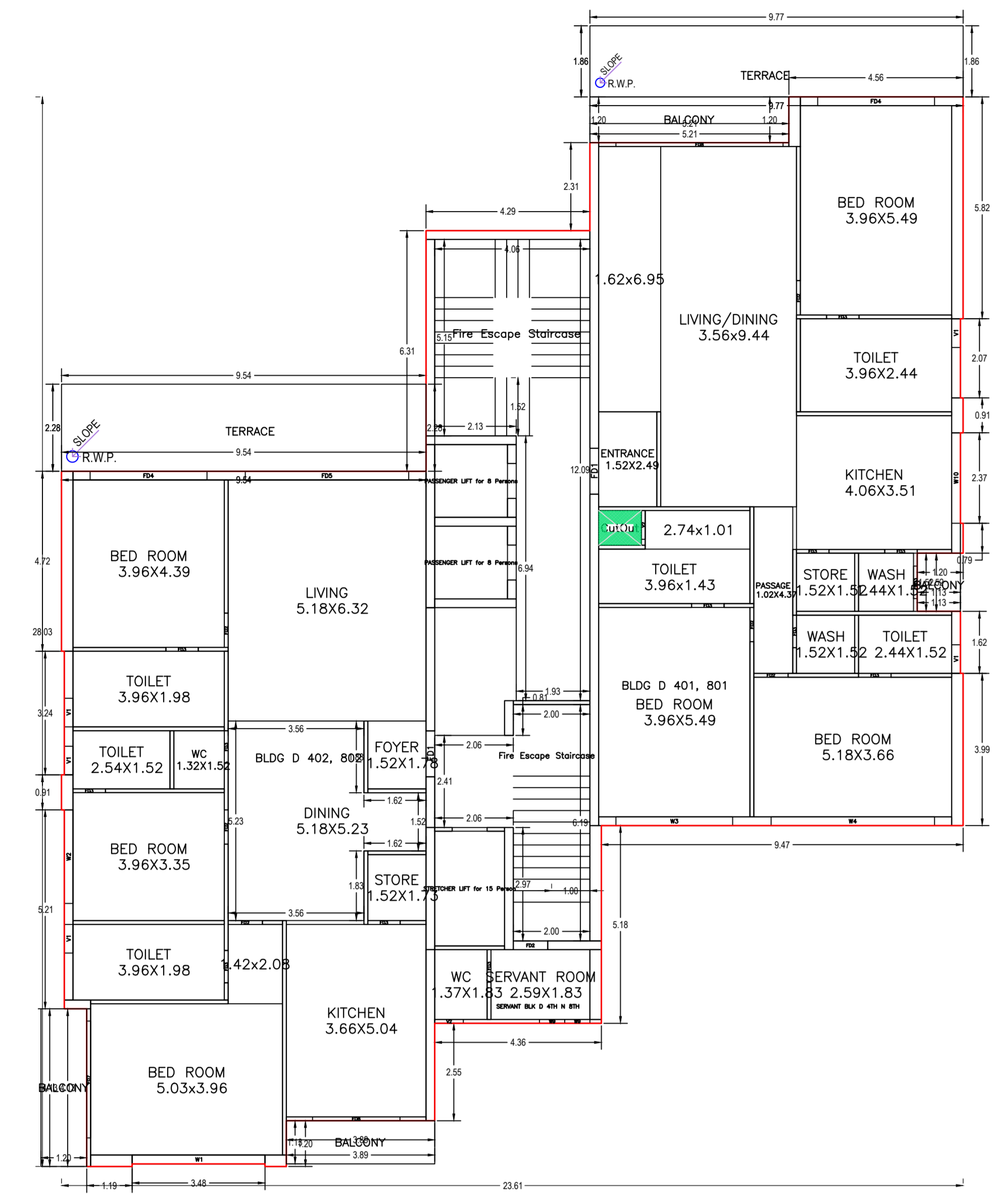
GROUND FLOOR PLAN

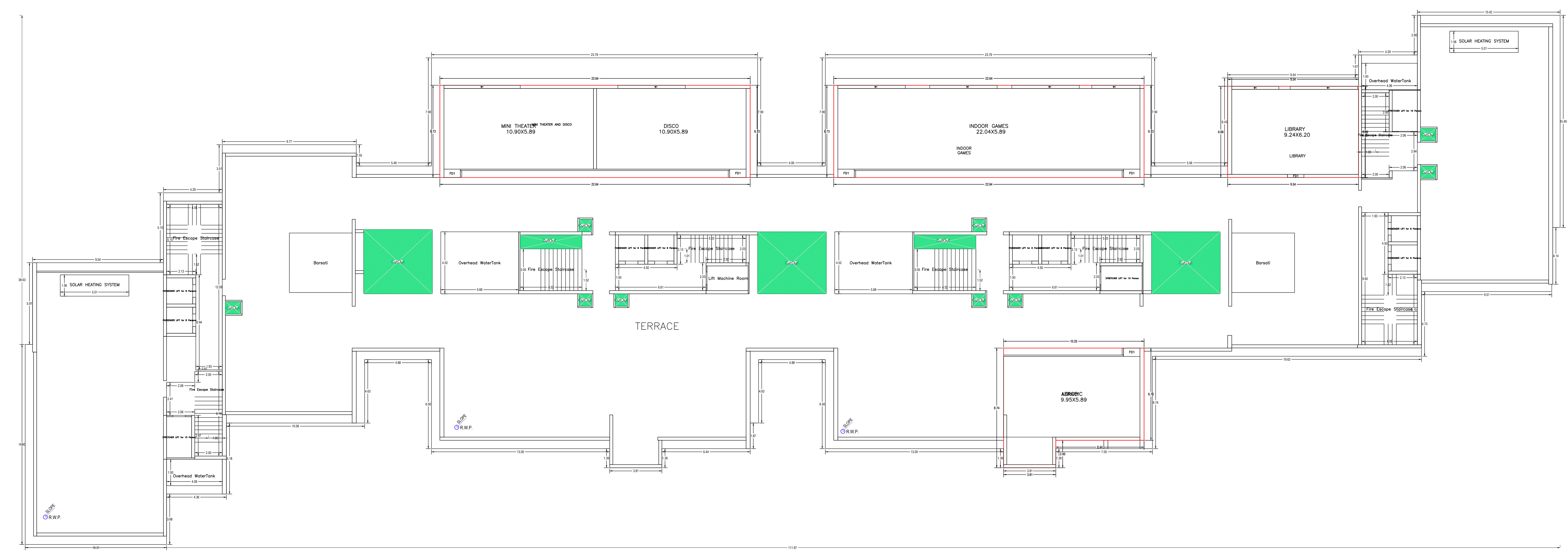

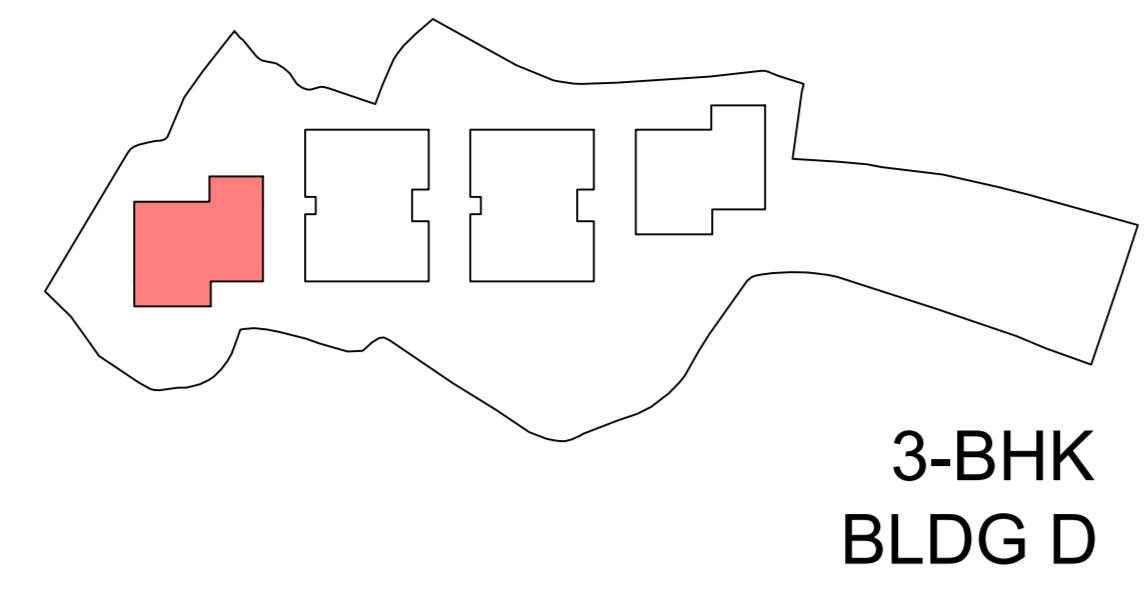
TYPICAL - 5 & 9 FLOOR PLAN

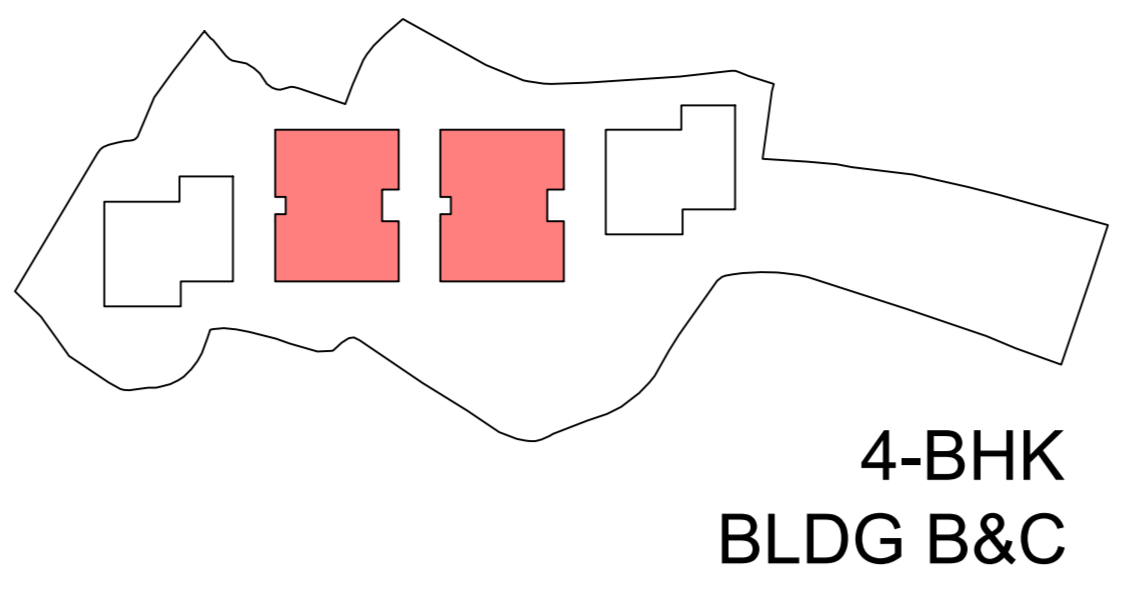
TERRACE FLOOR PLAN
