#### **BETWEEN**

**NISHAT TARNNUM** W/o TASNIM AHMAD, R/o: 14/L4, Road No 4, B.H.Area, Kadma, Jamshedpur, by faith Muslim, (Hereinafter called the donor of one part.)

AND

MANGO MUNICIPAL CORPORATION, MANGO (Hereinafter called the donee of the one part.)

whereas, the said donor is the absolute owner in possession of land premises situated at RS Plot No 547 Recorded under Khata No. 27, Thana No 1642, Mouza, Pardih, Ward No. 9, MNAC within, District- East Singhbhum, Jharkhand,

And whereas order to construct a building over a land mentioned herein above, the donor has got a building plan sanctioned by the Mango Municipal Corporation Vide BP Case No. MNAC/BP/0057/W09/2020

whereas for the development and widening of Road infront of the above mentioned land. the donor has left a strip of land for road/widening and is ready to donate the strip of land mentioned in schedule for the benefit of society as a whole.
