3. That the land stated above is not a tribal land for tribal land permission for transfer has been obtained vide case No _____ years from SAR, DC, Commissioner Court.

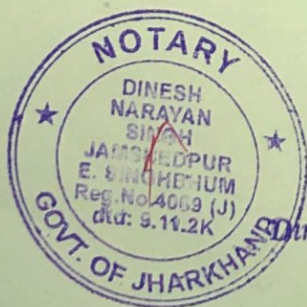
